FSS GENERAL UPDATES

FSS Ration Cuts Impact:

During the coordination meeting FSS discussed with partners about General Food Assistance (GFA) ration cuts impact in the Refugee community.

FSS lead agencies, WFP has 4 different types of Complaint and feedback mechanism process to collect the complaint and feedback from the beneficiaries. In the month of July total 647 ration cuts related issues/calls were recorded through WFP Hotline (97) and Helpdesk (5050) channels (where Male beneficiaries was 58% and Female was 42%).

Therefore, FSS requested partners to share their ration cuts impact or any challenges they faced to implementing their activity due to ration cuts.

Flash Update #2 on Monsoon Response of 5-8 August 2023

- WFP and its partners lead the emergency food assistance, distributing 458 cartons of fortified biscuits and 6,135 hot meals (2,514 for lunch and 3,621 for dinner) to 478 households (2,396 individuals) across the camps.
- MSI provided 1500 hot Meal (Birani) at Camp 10 and planning to response Coxsbazar upazila (except Ukhiya and Teknaf)
- WFP DRR team distributed BDT 4,100 to 5,343 HH of at Teknaf Upazila (3 Union: Teknaf pourosova, Sabrang and Nila) through Mobile money transfer (Bikas) as Anticipatory Action.
- The Sector is closely coordinating with resilience and livelihood partner organisations to monitor 832 fully damaged homestead gardens and 3,541 partially damaged gardens in the camps.
- AAB, OXFAM, Helvetas, assed the vulnerable affected beneficiaries at host and camp beneficiaries in the Ukhiya and Teknaf Upazilas.

AAP Training

AAP Technical Working Group, in collaboration with BBC Media Action, has been organized a workshop on 21 and 22 august focused on AAP for all sector partners. The workshop is developed based on the identified priorities of previous AAP workshop, aiming to integrate collective AAP practices across sectors. The goal is to offer strategic and technical assistance to the sector partners in different sectors, fostering a shared comprehension of AAP principles and empowering them with tools to incorporate these practices effectively. Moreover, enhance the integration of AAP within individual sectors. FSS nominated 6 FSS partners colleagues from the FSS partners for the workshop.

International Youth Day (Green Skill Conference)

Target Demographic: 40 Youth (host and refugee) + 30 participants from partners and Sector

Homestead gardening operational and technical guideline a minimum standard

Firstly, FSS thank to all technical colleagues who dedicate their time and provided their expert inputs on developing the draft homestead gardening guideline version 2.

Now FSS is going to finalize the compiled draft gardening guideline as a final draft, therefore FSS is planning to set a meeting with 3 technical colleagues for final review of the gardening guideline. During the coordination meeting, FSS requested to the coordination meeting participants to nominate 3 colleagues' technical colleagues for the meeting.

Proposed interested colleagues for final review (Colleagues -3): BRAC, FAO and Helvetas.

Partners are also requested to provided gardening relevant picture to FSS for guideline uses.

Homestead Gardening Research

During the coordination meeting, FSS briefly discuss on upcoming Homestead gardening research which will be carried out by the Rohingya students from AUW resident in the camps, and in close consultation with members of the FSS and Energy Environment Network (EEN). They research will be funded by Re-Alliance with a grant from the JAC trust.

The scope of the research is planned to include.

- 1. Some initial desk-based research into project documents from key project implementers and to include a range of International Agencies, INGOs and NGOs (we are dependent of members of the sector being willing to share reports and budgets). We hope this will yield
- The size of projects and costs per head
- Whether gardens used chemical or organic inputs
- Type of gardens implemented, home, school, community, rooftop etc
- National or heritage seeds, advice given on seed saving
- Length, scope and content of training offered (regenerative, permaculture, climate resilient etc), designed and delivered by resident, national or international personnel)
- Training approaches used, and type and availability of training material
- Follow up support offered
- Records kept of yields Kcas/month??
- Records kept of foods produced and consumed
- Comparisons of costs and approaches with range of foods produced and consumed and amounts of water used.

The research would hope to carry out this desk-based research during September, October and November 2023, depending on availability and accessibility of reports shared. Empirical research is planned to take place during the December break when it is hoped that, post elections students will be able to return to the camp. Permission will be sought for this early in November. This will include individual interviews with households participating in selected projects and transect walks to observe which gardens are still in operation, what they are producing and what sources of water will be used.

Semi structured interviews with participants will cover areas such as:

- 1) What have been the benefits of having a garden?
- 2) What different foods have you grown this year?
- 3) How much of this have you eaten? Your family eaten?
- 4) What difference has this made to food availability? Household budgets?
- 5) Do you notice any difference to your energy and health, or that of your family?
- 6) What (if any) new approaches did you learn from the training?
- 7) Which of these are you still using?
- 8) What if any follow up support have you received?
- 9) What are the main problems you have encountered in the garden?
- 10) How have you dealt with these

Therefore, FSS will send a email to the partners email list requesting for their consent to contribute to the research and provide research relevant information to us.

• AAB has distributed 10,000 agriculture inputs items in May and production has started, based on last month July production report in total 7203 Kg at different camp.

CWW

- Concern Highly interest to involve & Support upcoming Research initiative.

FAO

• In response of cyclone MOCHA, FAO has a plan to distribute winter vegetable seeds and Micro Gardening Kit (MGK) to 15,000 Rohingya households in the camp of Ukhiya and Teknaf sub-districts. For beneficiary selection, FAO is

communicating with UN agencies (WFP) for ongoing or leftover or affected households list and it will verify and finalize the list for the input's distribution. The inputs will be distributed in October 2023 in the camps with orientation.

- Helvetas implemented SHINE project by the implementing partner (Uttaran & Prottyashi)
- Working area 5 unions & 10 camps of Teknaf & Ukhiya Upazila
- 500 Commercial farmers (Household) received paper voucher for input purchase from the local seed vendor/retailors of Hinal & Whykong union under Teknaf Upazila for commercially vegetable production.
- 290 Household received agricultural input support for homestead vegetable cultivation at Halodiapalong union under Ukhiya Upazila.
- 1800 Household received agricultural input support for homestead vegetable cultivation at camp 8W.

- 10 Female beneficiaries received security loss fund through mobile money transfer for strengthening her exiting business mainly agro based.
