





#### November 2023 CO1 - Food Assistance

In November 2023, food assistance was provided to 3,122,642 individuals, reaching 85% of FSLC target. Among the beneficiaries, 78% received general food parcels, while 12.4% were provided with hot meals. Additionally, 9.3% received rapid response rations including bread, and only 0.2% obtained market-based relief vouchers. 67% of food assistance was allocated to non-IDPs, 31% to IDPs, and 1% to returnees. The bulk of food assistance, totaling 89%, was allocated to five specific oblasts: Donetska, Kharkivska, Khersonska, Zaporizka, and Dnipropetrovska. 40 reporting partners contributed to food assistance in November, including WFP, GEM, WCK, SPIR, U-Saved, WVI, AOS, GCS, Posmishka, URCS, Caritas UA, LH, PHK, DK, CFDE, ERC, PIN, ERC, GoodWill, AAH, NW, FFKR, R2P, ASB, NICCO, ACTED, Blahorob, HIA, 100% Life, NRC, BiY, LHI, EI, CNG, DUA, SVA, CORE, PIN SK, ForestCom, FZ, TBPUA.



The Food Security and Livelihoods Cluster (FSLC) was established in December 2014 and is led by the Food and Agriculture Organization (FAO) and the World Food Programme (WFP). The FSLC coordinates the food security and livelihoods response for more than 500 partners since Russia's full-scale invasion on 24 February 2022.

Response Under HRP 2023 More than 10 million people received food assistance in 2022. Humanitarian needs in areas where ongoing hostilities continue to escalate are increasing. Food insecurity is driven by the war, loss of livelihood opportunities, poverty levels, lack of access to food, and displacement. The number of people in need of food assistance is defined as those who are severely and moderately food insecure.





### INTRODUCTION TO UHF

The Ukraine Humanitarian Fund (UHF) is a <u>country-based pooled fund</u> aimed to support coordinated humanitarian action, in line with the <u>Humanitarian Response Plan</u> (HRP).

The UHF is led by the Humanitarian Coordinator, supported by the Advisory Board, managed by OCHA in cooperation with the Inter-Cluster Coordination Group.































### UHF KEY OBJECTIVES

- Prioritizes needs identified in the HRP and other guiding documents, like Flash
   Appeal, Winterization Plan, etc
- Provides rapid and flexible funding (through Standard and Reserve Allocations)
- Strengthens the leadership role of the HC
- Promotes coordination through OCHA Inter-Cluster Coordination mechanism
- Ensures inclusiveness and partnership with NGOs, promotes localization agenda

### ELIGIBILITY PROCESS FOR UHF PARTNERS

**UHF partners - NNGOs, INGOs, UN Agencies, Red Cross Organizations** 

**UHF Eligibility Process** (Annex 10 to the <u>CBPF Operational Handbook</u>):

Step 0. Request to ocha-uhf@un.org and online form submission

Step 1. GMS Registration (please e-mail ocha-uhf@un.org for detailed instructions)

Step 2. Due Diligence submission

Step 3. Capacity Assessment

**IMPORTANT:** Only organizations that have passed the Eligibility Process can see opened allocations and submit project proposals in the Grant Management System, while non-assessed partners may be sub-implementing partners in submissions led by an eligible partner.



























## 2023 UHF Partner Eligibility Minimum Requirements

- 1. Operating according to humanitarian principles of humanity, neutrality, impartiality and operational independence.
- 2. Valid registration in Ukraine with ongoing operations in-country.
- 3. Active membership and reporting to humanitarian cluster(s) in Ukraine.
- 4. Demonstrable partnership with donors, UN agencies and/or international organizations.
- 5. Programmatic expenditure/budget of at least \$200,000 for INGOs and \$100,000 for national NGOs per annuum in the last two years.
- 6. Having an operational bank account in USD or EUR in the name of the organization.
- 7. Demonstrable full programme cycle experience in project management.
- 8. Demonstrating a clear organizational structure and financial systems and capacity to manage and absorb funds.
- 9. Having a recognized form of governance overseeing the organization's operations



## **UHF Types of Allocations**

- Standard Allocation
- Allocated once or twice per year.
- Supports HRP priority activities
- Longer project duration upto 12 months.
- Most commonly used in other countries, but not in Ukraine due to a quickly evolving emergency..

- Reserve Allocation
- Rapid and flexible funding in the event of unforeseen emergencies/increase in needs or to address response gaps.
- Most commonly used in Ukraine.

The communication and details regarding the allocations and procedures are only available to eligible partners. Unfortunately, you won't be able to get such information if you are not eligible partner.

### 2- How to make one's proposal successful?

When the proposal is perfectly following the specific <u>allocation strategy</u> and responding to the actual needs in an efficient and effective manner

3 - If we are not an eligible partner, what are the opportunities for us?

Prior to becoming eligible and receiving direct funding from UHF, partners still have the option to work as sub-IP with UHF eligible partners.
