Building Blocks (BB) – Ukraine

- Since May 2022, **62 partners** using BB to date
- Prevented over 170 million USD in unintended assistance overlap in MPCA
- Collectively supported over **4.3 million** unique households
- **Shelter & NFI** cluster winterization assistance categories added in February
- ITFD activities found requiring inter-sectoral de-duplication with multipurpose cash (MPCA) currently deduplicated on BB
- Supported by WFP as a **service** available to all clusters and partners

Building Blocks – Overview

- Designed specifically for inter-organizational deduplication of assistance
- Deduplication WITHIN an assistance category AND inter-category / sectoral e.g., multi-purpose cash and food assistance
- Deduplication of anything of **value** e.g., cash, vouchers, in-kind
- Options to skip assistance, shift forward, provide a top-up value, duplicate etc. tailored to each cluster and assistance category, then user selected
- Data minimization and data protection principles at the core mean no sharing of beneficiary personal information, only assistance

Collaborating on BB: Community Agreement

- 1. Deduplication parameters: value (UAH) and time
- 2. Deduplication WITHIN an assistance category AND option for inter-category/sectoral e.g., multi-purpose cash and food assistance
- 3. First come, first served
- 4. Successful import is an obligation to assist
- 5. Organizations choose deduplication option or opt for assistance without deduplication
- 6. Loading of historical data
- 7. Removal of unsuccessful assistance


