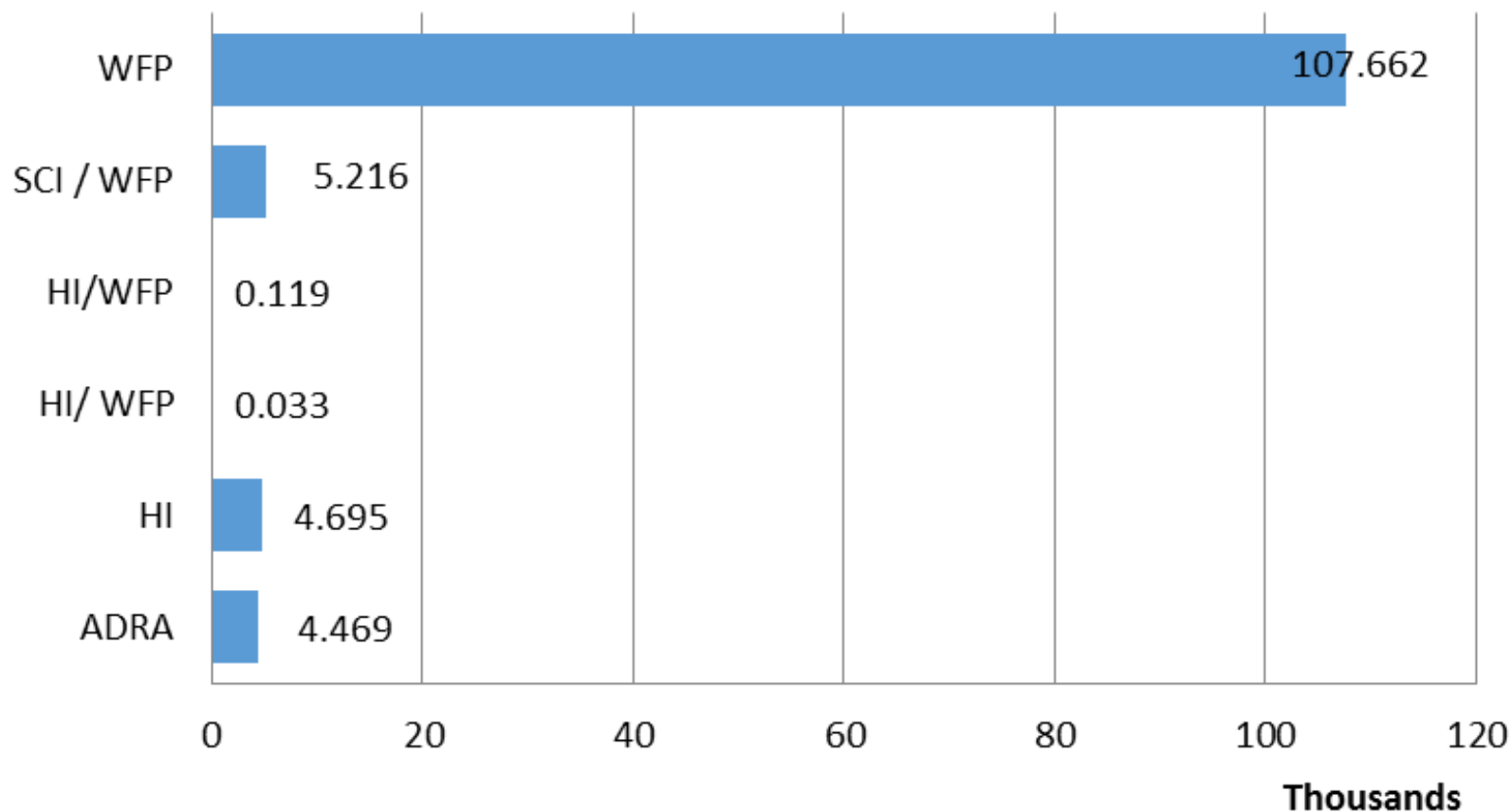

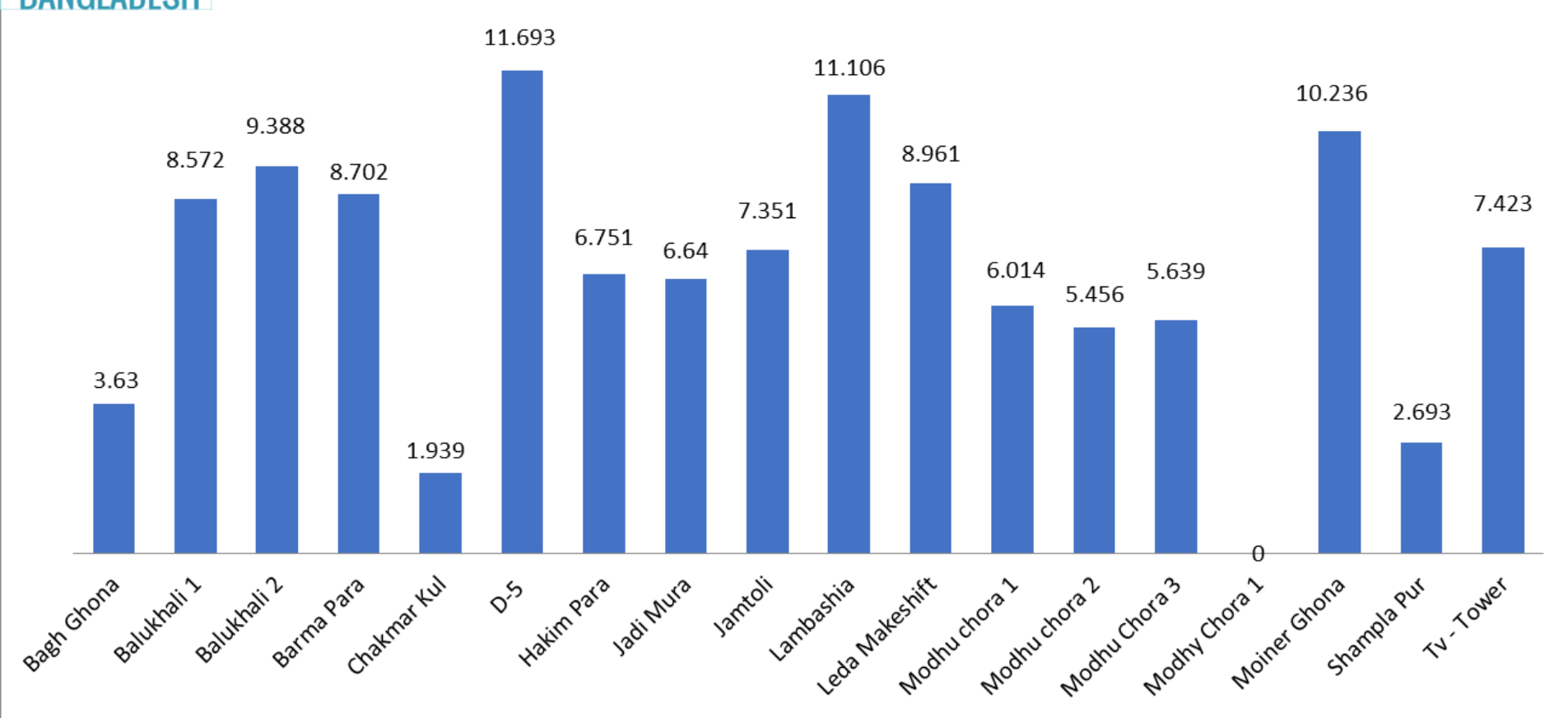
General Food Distribution Round 7 23 to 31 December 2017
