In regards to military escorts, civilians can use the road from 6 am to 5pm without any security escort, though there are military checkpoints between Konduga and Bama. In addition, there will be intermittent patrols along the road by the military on daily basis.

On 1 April, OCHA together with the INGO Forum met SEMA and the Ministry of 3R/Secretary of the Bama Relocation Committee.

- According to SEMA, 30,000 households (HHs) have been registered for movement to Bama, with an overall estimated figure to be relocated of 120,000 HHs.
- According to SEMA, 3,670 HHs have been registered as part of Phase 1 (mainly host community in Dalori) to start the relocation to Bama on 02 April.
- The humanitarian community emphasizes that through UN Guiding Principles on IDPs, and as stated within the Kampala Convention, any relocation or movement of IDPs must be voluntary, well informed, and consensual without discrimination to status or area of origin.
- Better coordination and more detailed plan from the government with the humanitarian community is requested.
- More information will be shared once more clarity is given on the situation on the ground and the planning of this government-led initiative.
- IOM/DTM will release a flash report on the population movement by the end of the day.

FSS Rainy Season Planning

- The need for coordinating food assistance and seed distribution to ensure proper use of seeds/seeds protection. There is still a significant needs for food assistance which may also cause beneficiaries to feed on seeds meant for planting. Close coordination between the two can make response more effective/impactful to the beneficiaries and ensure resilience.
- Harmonization: Partners to provide technical information (targeting criteria and kit composition/value) of its interventions for consolidation with technical guidance from FAO.
- Mitigation of duplication and gaps: FSS to release the partner presence and gap analysis maps: The draft gap analysis and partner presence maps based on Partner Intervention Plan (PiP) data (April to September) were presented and discussed in the meeting. The products are still being further polished/finalized as following that meeting, quite a few partners came back to the sector to re-submit their data with more updated information. They will be released this week.

Inter-Sector Flood Contingency Planning

This inter-sector rainy season (flood) contingency plan (CP) is complementary to the FSS-specific rainy season planning exercise. The former one emphasizes flood while the latter one focuses on agriculture & livelihoods activities planning (seed, agriculture, livestock fisheries inputs distribution) during the planting season (April to Sep) and the lean season (which is towards the planting season – June-Sep).

• Through analysis conducted using NASA/NRT Global Flood Mapping and 2017 CCCM camp flood risk and elevation data, there are an estimated 407,000 individuals in Borno, Adamawa and Yobe States who could potentially be impacted during this period. This includes 367,000 in Borno State, 27,500 in Adamawa State and 12,500 in Yobe State. Populations in need across Borno, Adamawa and Yobe States have been prioritized into three categories.

FSS to circulate intersector flood contingency plan draft for inputs and supporting documents.

- Those in Priority 1 include an estimated 325,000 IDP and host community populations living in areas that are hard to reach by road during the rainy season and that experience other high risk factors. This includes the following locations: Rann (Kala Balge LGA), Ngala (Ngala LGA), Dikwa (Dikwa LGA), Banki (Bama LGA), and Baga/Kukawa/Cross Kauwa (Kukawa LGA).
- o Those in Priority 2 include an estimated 60,500 individuals living in camps, settlements or villages across Borno, Adamawa and Yobe States where there are flood risks. They are prioritized in this category because they live in sites with more than 3,500 individuals, thus denoting more congestion and increased vulnerabilities with flooding.
- o Those in Priority 3 include an estimated 21,500 individuals living in camps, settlements or villages across Borno, Adamawa and Yobe States where there are flood risks. They are prioritized in this category because they live in sites with less than 3,499 individuals, thus denoting reduced vulnerabilities compared to populations in Priority 1 and 2 categories.

Update on CaLP mission on MEB finalization

- A revised version of the MEB based on the basic needs assessment report to be reviewed by sector
- The MEB is targeting the IDPs and host communities of 3 LGAs (Jere, Konduga et MMC)
- In terms of prices, the prices as per January version were kept for existing items and complete for the new additional items
- Calculation per household and consider the average size of 7 to draw on the MEB format of Cameroon
- The process to be finalized by mid-May with sectors' validation and participation.

Market assessment or cash transfer feasibility study/assessment is crucial, of which items are feasible to shift into cash, before looking at the appropriate modality where possible of multimodality approach (combination of cash and inkind).
Collect prices data	complete price data collection	 For conducting market analysis (PCMMA/EMMA), we will recommend for joint price market monitoring from local to intermediate market to capture and understand the market impact including other tools. FEWSNET, WFP/VAM have the existing assessment tools where we may jointly request for price monitoring. Note: LGAs near the Cameroon market borders (cross border currency): price of imported commodities (we know our reference is BNA for 3 LGAs but this something to be aware of. Post-distribution monitoring assessments to assess impact of CTP as a support to the CTP monitoring and evaluation conducted last March 29. It should include questions for cash PDM, vulnerability criteria and targeting integrate with gender and protection components
Updating the cash working group	Ensure a good global picture of the MEB	 As we agreed we used the BNA report as main reference (evidence-based report) to start with MEB road map. We know that MEB should link to global level but our main task is CONTEXTUALISE the MEB. It should be context driven after all sectors validation.
To share the MEB with the Abuja national CWG	National validation completed	 Many different views that constitutes an MEB - we should be clear here that this MEB is guidance for humanitarian response in North East based on evidence report of BNA. We know this MEB will be taken into consideration for country-wide context. However, for non-crisis to early settings, the CWG should inform the partners and sector/cluster that Nigeria has various poverty line that represents minimum consumption standards of essential goods and services.

Updates on Information Management

- FSS IM training took place in Yola, Adamawa on 27 March.

Updates from SAFE Working Group

The SAFE training on Energy, environment and people-centered approaches will take place on 04 April. The training fits in the Sustainable Energy Technologies for Food Security in Humanitarian situations (SET4Food) Initiative, aiming to improve access to energy of people in humanitarian contexts, especially for food security. The details and selection process of this training has been shared with partners.

Cadre Harmonize March 2018

- The official communique has been released.
- The number of people estimated to be facing critical and crisis food and nutrition insecurity in Borno, Adamawa, and Yobe states for March-May 2018 is 2.3. Million (IPC 3 to 4). (Compared to 4.7 million March-May 2017, and 2.6 million October-December 2017); June-August 2018: This figure is projected to reach 3 million during the 2018 lean season (IPC 3 to 4)
- This exercise was led by the Nigerian government (NPFS, Federal Ministry of Agriculture and Rural Development), contributed by several agencies, including WFP FAO other stakeholders involved in food security, nutrition, health, early recover and livelihood. It is a useful document for various sectors, including the Food Security Sector, to inform our targets and response, with the understanding that it is not a product of any specific sector.

6. PRESENTATION ON DISPLACEMENT TRACKING AND RETURN ASSESSMENT, BY IOM/DTM

- Brief overview on IOM/DTM work.
- Return Assessment covers people who displaced and PHYSICALLY returned back to their habitual residence
- Doesn't not include people who have returned to their LGA capital
- The word "Return" does not implies the durable solution (Physical return vs. Principled return).
- Pilot return assessments planned and will focus on:
 - Basic services available at the village level
