59 (fifty-nine) participants representing 39 institutions attended the FSLC coordination meetings. The institutions included donors, NGOs and international organizations (including UN agencies and the Red Cross movement).

1. Operational overview

Overview:

- A total of 35 organisations have submitted their 5Ws to the Cluster.
- 25 regions have been reported the highest reached figures were reported in Kharkivska oblast (1.7M approx), followed by Lvivska oblast (1.2M approx.) and Mykolaivska oblast (523k approx.)
- A total of 22 partners provided weekly updates to the cluster of people assisted. Five new
 partners were also reported. Three organizations have submitted plans for MPC, emergency
 agricultural inputs, and community livelihoods rehabilitation support. 17 oblasts were
 covered in total.
- The FSL Cluster has completed five rounds of 5Ws reporting (16, 23, 30, March, and 05, April). The next reporting period is April 13–19. (Round 5). Every Thursday on COB, OCHA creates partner presence and people-assisted dashboards (static and interactive). The products are built around the 5Ws clusters.
- According to the FSL Cluster partners' presence map, Kharkivska and Donetska oblasts have the most FSLC partners (15 partners each), while Ternopilska and Khersonska oblasts have the fewest (15 partners each) (2 in each). The FSLC partners are well-represented in Ukraine's eastern, central, and northern-east regions, as well as in Lvivska oblast. Cash transfers are implemented in the oblasts of Khersonska, Mykolaivska, Ivano-Frankivska, Chernivestka, and Kharkivska.

2. Update on Flash Appeal – FSLC revised PiN, Target and Financial requirement

- There are about 10,2 M people in need (PiN).
- About 7 M people are targeted by the cluster.
- Almost US\$470 million financial requirements for covering the needs from March-August 2022.


