## New Strategic Objectives

- 1. Ensure protection, dignity and safety.**
- 2. Provide efficient and timely life-saving assistance and contribute to improving living conditions.**
- 3. Support social cohesion and increase capacity to cope with future shocks.**



# Government standing – RRRC circular dated 23/Nov/17

Reference: Memo # 03.07.2666.661.62.045.17 dated 15/Nov/2017 from NGO Affairs Bureau, the Prime Minister's Office

The necessary emergency relief (commodity/service) activities (FD-7) for forced displacement shelter less Myanmar citizens:

- a. Solar light establishment on streets
- b. To solve cooking crisis, (1) supply of Compressed Rice Husk, (2) Establish Gas cylinder based community kitchen, (3) Establish Biogas plant and (4) Solar burner, etc
- c. Supply of winter clothes
- d. Supply of medical equipment's (Ambulance, X-ray machines, ICU, Operation Theatre) at Teknaf, Ukhiya, Ramu and Cox's Bazar Sadar Hospitals
- e. Due to the destruction of forests, conduct research in determining the disposal of habitats of elephants and other wild animals
- f. Listing of the physical and mental disable people and supply of necessary instruments
- g. Adult and technical education
- h. Remove the useless toilets and sludge removal activities.

# Prioritization of Livelihoods – review of Shelter Sector needs

Shelter/NFI actors may be looking to stimulate livelihoods, particularly in the host communities as well as within the refugee communities, to:

- a. increase brick production
- b. expand bamboo matting fabrication capacity
- c. create nurseries for grasses and vegetation suitable for soil stabilisation
- d. increase production of precast concrete culverts (drainage)
- e. stimulate a supply chain of pre-cast concrete foundations / posts
- f. increase local capacity to treat borak bamboo
