Beginning in March, the FSLC will collect input from partners to update the NAWG on a monthly basis. Partners will share their NAWG update with their state and/or county focal point, and the focal point will then share their area update with the national level for review (by the FSLC food security analyst) and inclusion in the analysis.  The FSLC National Coordinator presented the progress of the FSLC since the last meeting: Improving sub-national coordination with the support of FSL Cluster State/County Focal Points. A first meeting was held with them on March 7th and similar meetings will be held monthly to discuss the challenges and provide support needed to implement the FSLC strategy and coordinating the humanitarian response. 	Implementation of FSLC 2024 work plan will begin on March 20 th , following validation by FAO and WFP, the Cluster Lead Agencies (CLAs). Link to the presentation here.

3.	Food aid gap analysis	Next Steps / Action Points
The FSI	LC updates a monthly food aid gap analysis based on CO1 (Food Aid) partners' plans. To do so, the FSLC compares partners GFD and MPC plans with HRP targets (IPC4+ population). Identifying gaps helps direct resources to the most acute needs and advocate for adequate resources.	FSLC will share a template with FSLC partners to collect inputs about their non-WFP GFD and MPC plans to determine the response gaps. Gap analysis map link is here
4.	Integration between food aid (CO1) and emergency agriculture (CO2)	Next Steps / Action Points
assista	the key priorities of the FSLC 2024-2026 strategy is the integration of complementary food nce activities: food aid (CO1) and emergency agriculture (CO2). To implement this priority, FAO and WFP have launched a pilot in 23 counties where FAO will provide some livelihood support (Main Season Response) to the same beneficiaries that WFP supports with food aid. This pilot will be coordinated at the field level by WFP and FAO field offices in close coordination with the FSLC. The results of this integration will be evaluated to determine its impact and how it supports beneficiaries.	FSLC partners with bilateral funding (non-WFP or non-FAO funding) will be guided by the FSLC Subnational Focal Point to participate in this integration of services. Link to presentation Here
