OVERVIEW OF The PROJECTS

WFP Relief Project in Elbur

WFP relief project was rolled in December 2023 and is scheduled to conclude in April 2024 through submitted proposal for extension. This project covers 8 villages in Elbur and aims to assist vulnerable individuals who were displaced from their homes due to military operations

Cont.....

The project is providing cash transfers to 3000 beneficiaries and in-kind assistance to 984 beneficiaries. In April, an additional 262 beneficiaries will receive assistance. All beneficiaries have already received their entitlements for the period from January to March 2024.

AICS Cash Support Project

The AICS project commenced in August 2023 and is set to end on 31st July 2024. This is an integrated project of Health, Nutrition, Protection and Food security, the Food security component targets families with children 6-59 months admitted into the programme with severe acute malnutrition (SAM) and supports family food basket while the child is under treatment for SAM, each family will get cash support for three months, children are screened and in Waxaracde in Dhusasamreb and Kaah health centre Guriel.

Cont.....

So far total of 433 families were registered and will be receiving cash assistance @\$70 per month for three months.

Definition of AICS Project

The AICS project is a large project that operates worldwide. In Somalia, it supports a primary health care project implemented by CISP in 2 health centres in Dhusmareeb and Guriel. It includes various components such as, Health, food security, nutrition and GBV.

- Clear feedback from all partners





Needs

Below are figures from the Adado fact sheet based on the recent assessment. Below are number of people displaced and need Supply of food aid and cash transfers to help families meet their basic needs.

- 820 HH who relocated from Camara to Adado.
- 110 HHs from Bacadwane to South Galkacyo town.
- 30 HHs from Bacadweyne to Mirjicley.
- 100 HHs from the rural areas of Bacadwane to Wisil town.
- 60 HHs from Bajeela town relocated to Hobyo town.

Based on the assessment done on 1-5th February in the below villages in Hobyo and Harardere District, only 770 HH out of 10,070 HH have reliable food access through WFP assistance.

Bacadweyne, Dhaghaye, Laas gacamey, Camaara, Qeycad, Baraag ciise, Xinlebi, Seego, Sirgo, Cadale and Guroleey.
