2. Partners' regular update – ongoing response, plans & challenges.

- Ongoing Projects for the emergency food assistance by NRC, Maharati, RDF, RDP, Direct Aid, CARE, ICRC, SCI, PUAMI, ZOA, ACTED, and DRC will be reflected in the FSAC IM tool.
- Ongoing Projects for the livelihoods by the FAO, UNDP, WFP, VHI, ZOA, RADF, BFD -IRY, SMEPS, Response Foundation, NFDHR, LMMPO, RDP, SDF and SFD will be reflected in the FSAC IM tool.

NRC: updated that as

- NRC added new 45 HHs to the previous targeted 485 HHs to be 539 HHs in Az Zuharà district in Hodeidah.
- They have a plan for MPCA with 608 HHs.

ICRC: updated that as

- They planned two round food distribution to 2000 HHs in Az Zaydiyah district and 1000 HHs in AL-Hujjaylah district in Hodeidah. This is done in close coordination with FSAC Hodeidah hub.

LMPPPO: has updated that:

- At the final stage to finalize the Planning to prepare the business plan for the beneficiaries.

Islamic Relief-: IGNAITE project has updated that:

- The four selected value chains completed e.g. 40 HHs beekeepers (One Value chain), 120 HHs agricultural inputs (Farmers, two value chain) 200 HHs Restock of small ruminants (one value chain),
- Completed the selection for 4 villages in Bait AL-Faqiah district.
- The targeting process are ongoing in the selected areas.

BFD: has updated that:

- In Hodeidah The targeted beneficiaries in Bajil and AL-Qanawes are 300 HHs each. The activity is FFA funded by WFP ERRY 3. The project is going on.
- In Al-Mahwit the targeted district is At Tawilah with 350 HHs with FFA and 150 for microbusiness support.

CARE as FSAC partner in Hodeidah hub have updated that:

Save the children, has updated that:

- They have a plan to target 3,900 HHs by UCT in both Bajil and bait AL-Faqiah districts in Hodeidah funded by BHA. The same areas to be targeted by 2,300 HHs funded by GMOFA.

NFDHR updated that:

- Continue their targeting process for the a economic empowerment projects for the year 2024 in Al-Marawaa, Al-Zaydiyah, and Al-Duraihim districts, Hodeidah Governorate.
- The project is funded by Direct Aid for three districts, Al-Marawi'ah Al-Zaydiyah and Al-Duraihim, for 80 beneficiaries.

VHI: Has updated that:

- VHI in AL-Mahwit updated that the achievement in cash-for-work activity and the number of beneficiaries is 210 HHs. The trainings start as the planned training is for 50 beneficiaries.
- They are continuing the process for targeting the 200 HHs through the vocational training e.g. farm schools, sewing, etc. (without provision any kits) in AL-Khabt district.
- VHI in Raymah in AL-Jabin, Bilad Attu aim and AL-Jafariyah districts continuing their targeting process for 1212 HHs by FFA.

ZOA: Has updated that:

- ZOA is continuing their project targeting 120 HHs for the vocational trainings and 300 HHs cash for work in Al Khabt district of Al Mahwit. The project is YHF-OCHA funded.

Direct Aid: Has updated that:

- Direct Aid distributed the final round for 2410 HHs in Az Zaydiyah and 1930 HHs in Ad Duraihimi districts. The project has come to an end.

Maharati: Has updated that:

- Maharati distributed the Sixth round for 100 HHs in Ad Duraihimi district. The project is Pure-Hands funded.

3. FSAC Mitigation Plan

During the FSAC subnational coordination meeting in Sunday 28th April 2024, for Hodeidah hub (Hodeidah-Raymah and AL-Mahwit governorates) FSAC sub-cluster coordinator presented the [Yemen Food Security and Agriculture Mitigation Plan 2024](#) in the meeting. Key points form the mitigation plan are outlined in below:

- The presentation outlines the Yemen Food Security and Agriculture Cluster Mitigation Plan for the period of April to December 2024.
- The plan aims to alleviate the severe impacts of the WFP pause in humanitarian food assistance

- (HFA) in areas controlled by the DFA in Yemen.
- The mitigation plan aims to alleviate the severe impacts of the WFP pause. In addition to the WFP pause, historically, the period June to September marks the peak of malnutrition and food insecurity in Yemen from the seasonal trends.
 - It highlights that 17.6 million people in Yemen are food insecure, with 13.2 million in DFA areas experiencing emergency food insecurity.). Out of that 4.7 million people in DFA areas experience emergency food insecurity (FSAC 2024 HNO).
 - The FSAC has identified 48 high-priority districts based on the latest analysis done by WFP Vulnerability, Analysis and Mapping (VAM) unit and the Integrated Famine Risk Reduction (IFRR) approach. This includes, 22 IFRR districts and 26 WFP hot-spot areas
 - WFP's pilot retargeting exercise in DFA- areas is on track. If sufficient financial resources are received, the retargeting exercise will enable WFP will restart its Humanitarian Food Assistance as per the December 2023 agreement as soon as possible, likely in August 2024.
 - The food security situation will likely deteriorate further if the pause continues, especially due to the upcoming lean season. The nutrition cluster anticipates a 20% increase in wasted children requiring treatment.
 - The pause led to the prevalence of poor food consumption among the beneficiaries of WFP HFA increased from 23% towards the end of 2023 to 38% in February 2024, and the prevalence of inadequate food consumption increased from 58% to 66%.
 - The mitigation plan adopts the "Twin-Track Approach" to bolster the resilience of affected populations while simultaneously addressing their immediate food needs.
 - The plan does not replace the broader food security response in Yemen, as outlined in the 2024 Humanitarian Response Plan. FSAC partners will continue implementing programmes according to the HRP in parallel with the mitigation plan.
 - The FSAC response is currently underfunded, with a gap of 1.7 million individuals in HFA coverage within the high-priority districts.
 - The plan highlights prioritization in districts with rapid deterioration and severe food insecurity.
 - It mentions the need for funding and coordination with other cluster partners' responses.
 - The plan also discusses the operational capacity of FSAC partners and program approaches, including in-kind distribution and cash transfers.
 - FSAC encouraged partner organizations to actively participate in the implementation of the plan, particularly in high-priority districts where the severity of food insecurity is higher.
 - FSAC requested support and collaboration from partner organizations to mobilize additional funds for regular HFA and to address food insecurity in 8 districts prioritized in Hodeidah and 4 districts prioritized in Raymah and 1 district prioritized in Al-Mahwit.

Action point

4. Update in Unconditional and Conditional Cash Transfer Value- April 2024

FSAC completed analysis of data received from FAO, WFP and REACH on Exchange Rate and MFB price monitoring. Based on that FSAC has updated Unconditional and Conditional Cash Transfer guidelines in April 2024 guiding partners in delivering principled and impactful response. The updated and developed guidelines are as follows:

4.1. UCT for MFB Transfer Value

- Based on the market price data for the reference period July to December 2023, the harmonized transfer values of the FSAC MFB for a household of 7 members is as follows:
 - SBA controlled areas/governorates: 58,000 YER/household/month. This is equivalent to 110 USD /household/month.
 - IRG controlled areas/governorates: 140,000 YER/household/month. This is equivalent to 97USD rounded to 100 USD /household/month.
 - The revised MFB value came into effect on 29.04.2024.

4.2 Conditional Cash Transfers Value, April 2024

- Based on the General Principles of CCT Programmes in Yemen, the monthly CCT values is the following:
 - **IRG AoC, (140 000 YER/100 USD) * 110% = (154,000 YER/110 USD).**
 - **SBA AoC, (58,000 YER/110 USD) * 110% = (63,800 YER/121 USD)**

The revised CCT value came into effect on 29.04.2024.

- All partners are encouraged to fully adhere to both guidance and reach out to FSAC indicated at the end of the guidelines in case you have any questions or need more clarification.

Action point

FSAC partners to comply with the revised guidelines and promptly notify FSAC of any programmatic challenges they might encounter.
