Cumulative Summary since the 24 February:

- **Individuals Reached:** **6.25 million** people (approx.) have been assisted through either completed or ongoing activities
- **Reporting to cluster:** A total of **39 organisations** have submitted their 5Ws to the Cluster.
- **Locations:** **24 Oblasts and Kyiv** have been reported – The highest reached figures were reported in Kharkivska (1.6m approx.), followed by Poltavaska (507k approx.), Kyiv city (459k approx.), Zaporizka (417k approx), Dnipropetrovska (411k approx.).
- **Livelihood Activities:** 3 Organisations have reported ongoing/ completed distribution of Emergency Agricultural Inputs. In total 15 Oblasts covered, with a Total Reach of: **87k**
- **Top 3 Activities:** [approx.] Hot meals: **853k** / In Kind Food Distribution: **2.6m** / Emergency Food Kits: **2.52m**

Round Update (18 May– 24 May)

- **Reporting to cluster:** A total of 11 partners provided their updates to the Cluster
