

Cadre Harmonise

- o <u>Results</u> from the just concluded Cadre Harmonise workshop (March 2021) were presented with the <u>maps</u> showing food and nutrition insecurity phase classification in Cameroon, some of the highlights can be seen below;
 - 1,153,396 people estimated as severely food insecure (CH phases 3+) during the current period March-May however a slight drop to 954,618 is projected for the period June-August.
 - 20% increase in food insecure estimates compared to October 2020
 - 657,359 food insecure people in NW
 - 496,037 food insecure people in SW
 - 12 divisions out of 13 are classified as phase 3 (only Ngo-Ketunjia is phase 2)

MSNA Results


- IOM with coordination support from OCHA conducted the Multi Sectoral Needs Assessment in the NWSW regions and key finding and results relating to the FSC were presented. The full data can be requested directly from IOM by filling the data access form, below are some of the findings from the assessment;
 - 1,736 villages were assessed out of which 214 villages were either deserted or had insignificant IDPs
 - 813 villages in NW
 - 709 villages in SW
 - 410,993 displaced persons
 - 333,915 returnees
 - Food was identified as priority need in 29% of the villages assessed




• Information Management

• Capacity Needs Assessment

- To better understand the capacity needs of the FSC partners, a quick online survey was conducted to allow for effective preparation of possible capacity strengthening programs within the year.
- The results of the survey showing the capacity needs as per priority was also presented and the cluster is planning to provide trainings in line with the current COVID-19 restrictions and very limited resources.





	Agriculture & Livelihoods package guide All inputs from the technical committee have been consolidated and will be presented at the next ad-hoc meeting scheduled next week for all partner consent after which it will be sent to FAO Yaounde for final technical review for adoption.	
5	CCPM validation exercise Separate CCPM validation workshops were organized twice however, the participation were very low which won't be representative so the workshop was adopted as an agenda point during the FSCC meeting where most partners will be present. This only allowed limited time for discussion of the CCPM results so only questions with either satisfactory or unsatisfactory feedbacks were further discussed to understand how the cluster could improve in that regard. Though the general feedback in the meeting is not very much as partner seem to be positive that the cluster performance is already getting better, the few comments from partners were recorded into the feedback template for sharing before final adoption of the CCPM results.
