Introduction



General Updates

- **WFP and UNHCR/GoB re-alignment** – from 1 to end February 2020 (see [messaging](#))
- **Referral SOP** WFP – UNHCR /IOM to refer not matching cases
- **JRP 2020:** almost finalized, FSS Monitoring Framework, presented in Geneva on 2 March

SO4: Work towards achieving sustainable solutions in Myanmar.

Support Rohingya refugees to build the skills and capacities that would help with their sustainable return and reintegration in Myanmar when conditions become conducive, including in improving their access to education and skills development activities; ensure Rohingya refugees have access to safe, transparent, and consultative communication mechanisms regarding solutions and the situation in Myanmar; in Myanmar, continue to encourage and support the Government to address the root causes of the crisis, including through implementation of the Rakhine Advisory Commission recommendations, and create the conditions that would be conducive for safe, voluntary, and dignified return.

- BDRCS Dumba meat distribution, DC instruction no in-kind distribution
- County Cluster Performance Monitor (**CCPM**) **survey** – work-shop and work-pan

General Updates

- **REVA 3** presentation tentatively beginning of March (Save the Date)
- Market assessment – drafting
- Expansion of **Farmer's Market** assistance
 - Pilot project implemented by Relief International is linking smallholder farmers around Camp 7 and 2E
- Increase of **E-voucher value** from 770 to 840 BDT based on MEB revision – from 1 February 2020 (see MEB brief in [FSS Google Drive](#))
- Reduction of **Complementary Food Voucher (CFV)** assistance in line with **E-voucher** rollout
 - Number of camps needing CFV will reduce to 2 camps from April 2020
- **FSS Co-Chair** selection process

Updates on Complementary Food Voucher assistance

Transition plan:

March – 4 camps (3, 5, 8W, and 9)

April – 2 camps (1E, and 1W)

May – 4 camps (2E, 7, 14, and 23)

Possible delays:

Monsoon rain and challenges in rolling out several outlets in a month may delay the rollout

Updates on Farmers Market

Track 1: beneficiaries who are receiving in-kind rations

Track 2: targeted food assistance to extremely vulnerable households

Scale-up plan:

- BDT 125 will be transferred to beneficiaries' SCOPE card twice a month – total 250 BDT per individual
- To open 2 farmers market in each WFP catchment area (8 in total) using General Food Distribution points where possible

To align CFV programs and farmers market
