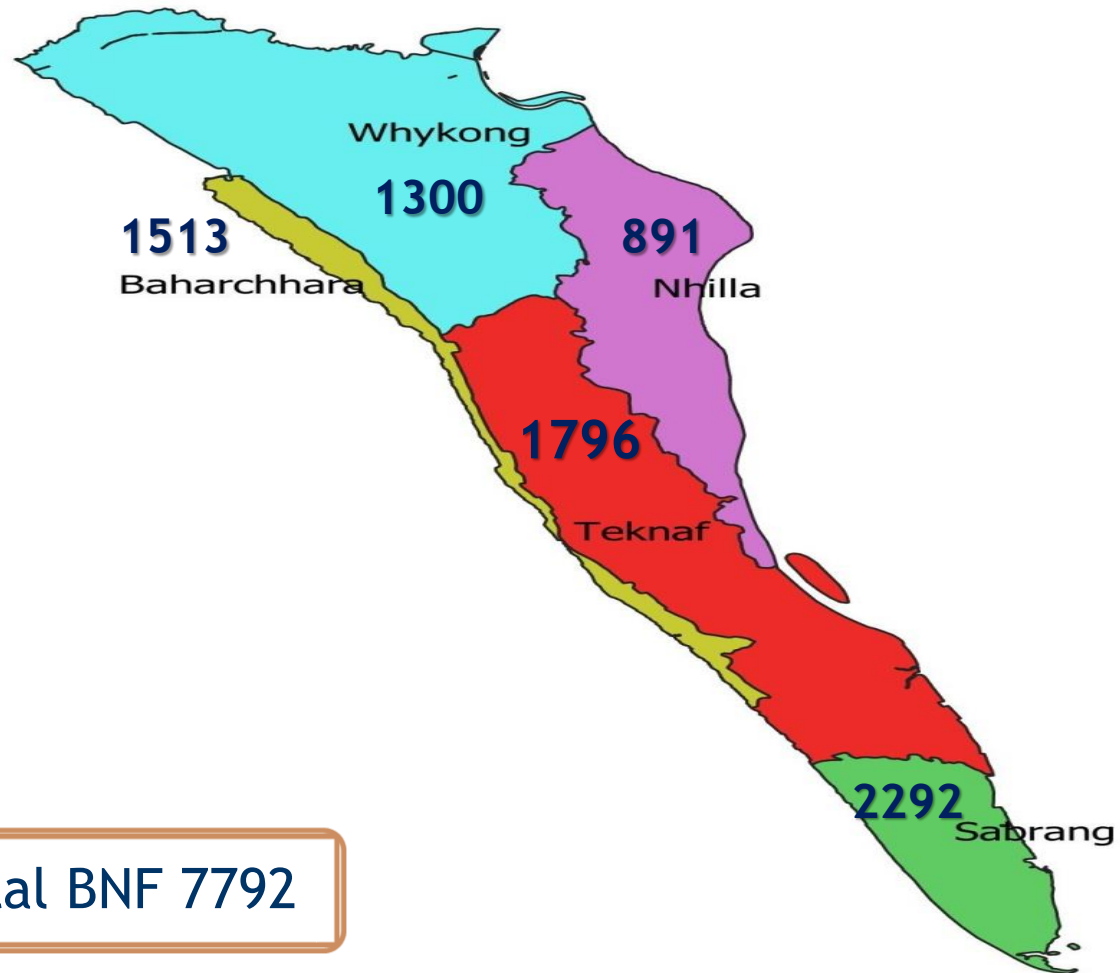

## Good Practices

- ❖ In case of input collection (chicks, hen, feed), the SHG are bringing together as a result input/production cost are reduced.
- ❖ In case of any emergency treatment, the Self Help Group (SHG) communicate immediately with Upazila Livestock Office so that proper support is ensured.
- ❖ Self Help Group (SHG) and Individual level production are accumulating at a specific center for selling as a result beneficiaries/SHG are getting fair price.

# Challenges

Challenges faced	Mitigation Strategy
Socially more conservative and women cannot move freely.	<ul style="list-style-type: none"><li>• Awareness session (BCC), training, frequent communication</li></ul>
Upazila livestock office (ULO) is far distance from the community, so vaccine collection from ULO was also a big challenge for vaccinator	<ul style="list-style-type: none"><li>• EFSN-III project providing vehicle support to reach the vaccine on time as per demand.</li><li>• At the same time when the vaccinator come to Upazila for their own business, they collect vaccine from ULO</li></ul>
All the vaccinators don't have freeze to preserve the vaccine.	<ul style="list-style-type: none"><li>• Vaccinators use other people's freeze whenever, wherever getting the opportunity</li></ul>
Distilled water is not available in Teknaf areas	<ul style="list-style-type: none"><li>• Vaccinators use filtered water</li></ul>
Low egg price and high feed price due to Lock down (COVID-19)	
Lack of technical knowledge of farmers for Livestock rearing	<ul style="list-style-type: none"><li>• Provide training, regular farm visit by LO and field level staffs, linkage others GO-NGOs stakeholders</li></ul>
Medicine and feed outlets are far distance from the farm/community.
