Subject: To take actions to mitigate the spreading of COVID-19 in FDMNs camp.

 2) Memo no. RRRC/RHU/COVID-19/Report/28/2020/432, dated 25/01/2022 of this office.

In reference to the above subject, undersigned is directed to inform you that COVID-19 pandemic situation has been deteriorating in the 'Forcibly Displaced Myanmar Nationals' camp area. It is assumed that the number of positive cases will increase in upcoming days. It is to inform you that concerned RIRT (Rapid Investigation and Response Teams) have been working in the camp in coordination with concerned Camp in Charges. To mitigate the situation, a comprehensive effort is required from all concerned.

2. The presence of staff of all organizations shall remain 50%, which can be implemented by following rotation and work from home module. This also should include physical distancing measures, use of personal protective equipment (wearing masks), hand washing and temperature screening at entry points. Health facilities and services should be excluded from "50% staffing" policy.

3. All Learning Centres (LCs) shall remain closed till 21.02.2022.

4. A control room has been opened at this office to disseminate information and coordination. You are requested to contact with Dr. Abu Toha Md. Rezuanul Haque Bhuiyan (01614331815), Health Coordinator and Dr. Md. Sarwar Jahan (01847424151), Assistant Health Coordinator of this office in any need.

5. You are requested to instruct your partner organizations to strictly follow all the above-mentioned instructions. They must ensure physical distancing measures, use of personal protective equipment (wearing masks), hand washing and temperature screening at entry points in case of operating activities in FDMN camp area.



Compost – WASH Partners

Organic material accounts for at least 60% of the total amount of waste generated in camps, and Cox's Bazar District in general.

Organic waste, if well segregated at source, can be turned into compost, which is both a soil fertilizer and a soil amendment. Compost can be applied in tree plantation, greening shelters, growing vegetables, restoration of soil, etc.

WASH Sector partners are producing compost in the camps on a regular basis. Compost can be donated to FSS partners who are doing homestead gardening projects in the camps. 58,419 kg of compost currently stored at Material Recovery Facilities
