


Probably one of the best Clusters in Ukraine is FSLC. Well-organized and higly responsive to Cluster participants.






The Cluster is well-driven on evidence-based data to formulate planning and action in supporting its humanitarian efforts including opportunities for early recovery.


What is HC HCT? Since so many people are new to UN because of how big this war is - it is helpful when Info is shared to put in parenthesis what acronyms mean.






