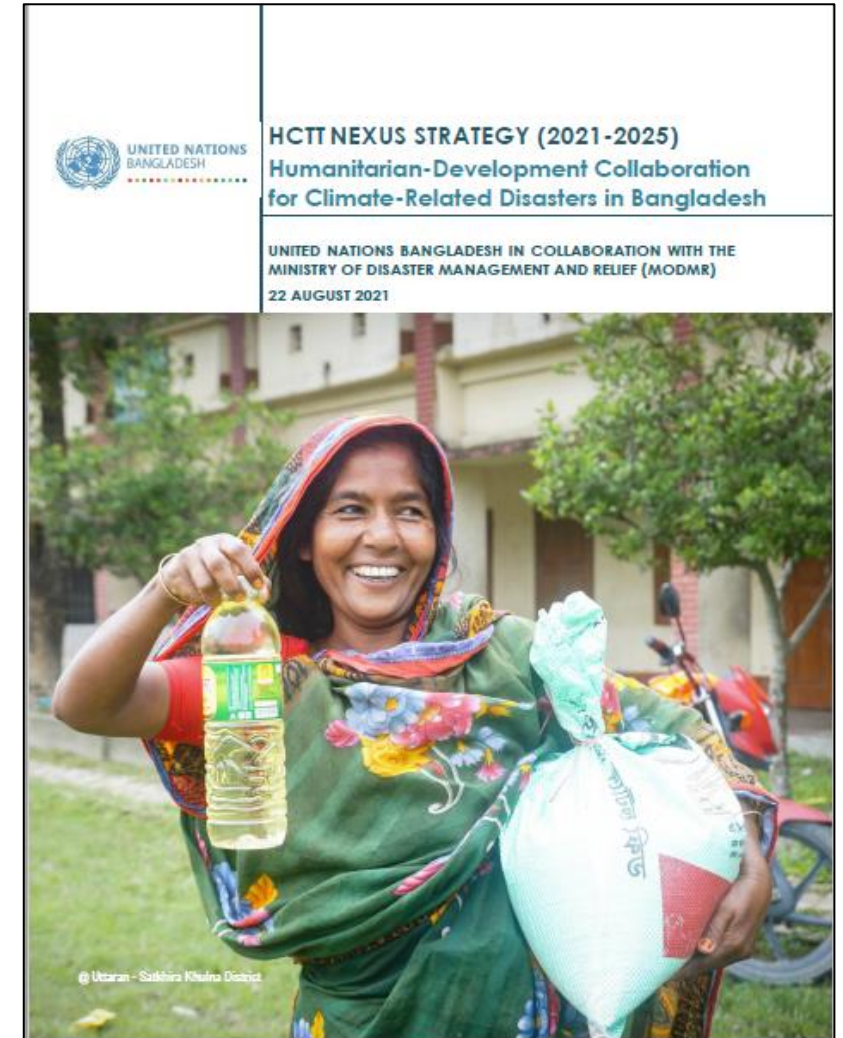




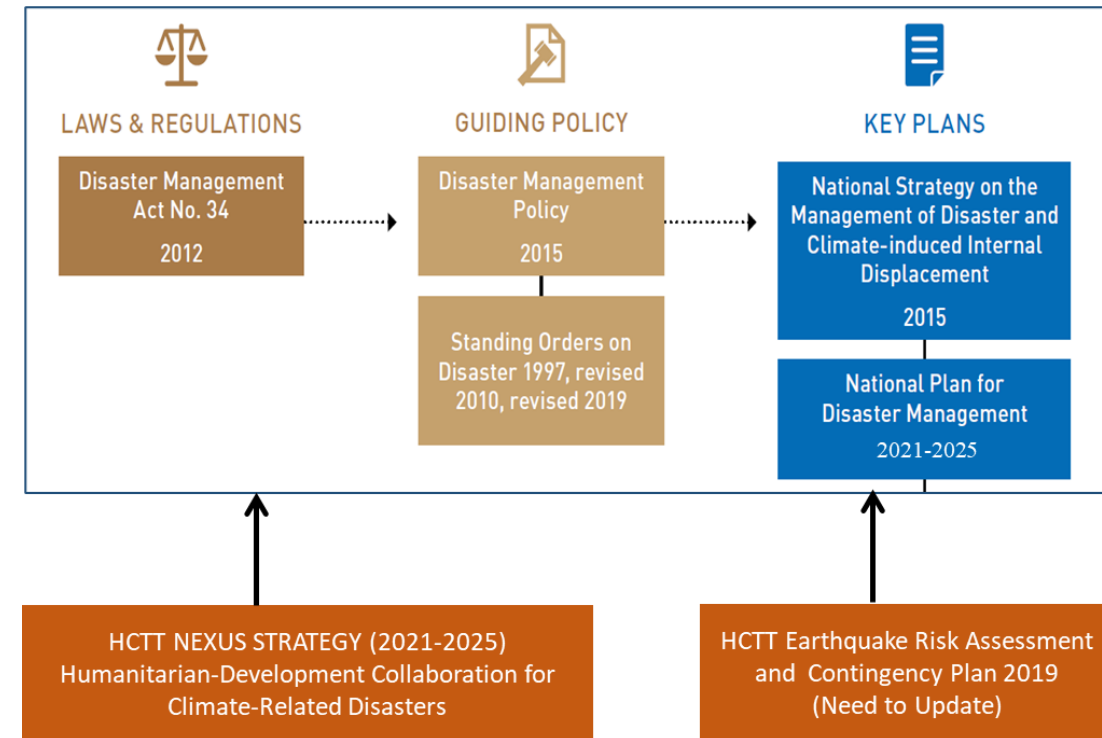
# Implementation of HCTT Nexus Strategy (2021-2025)

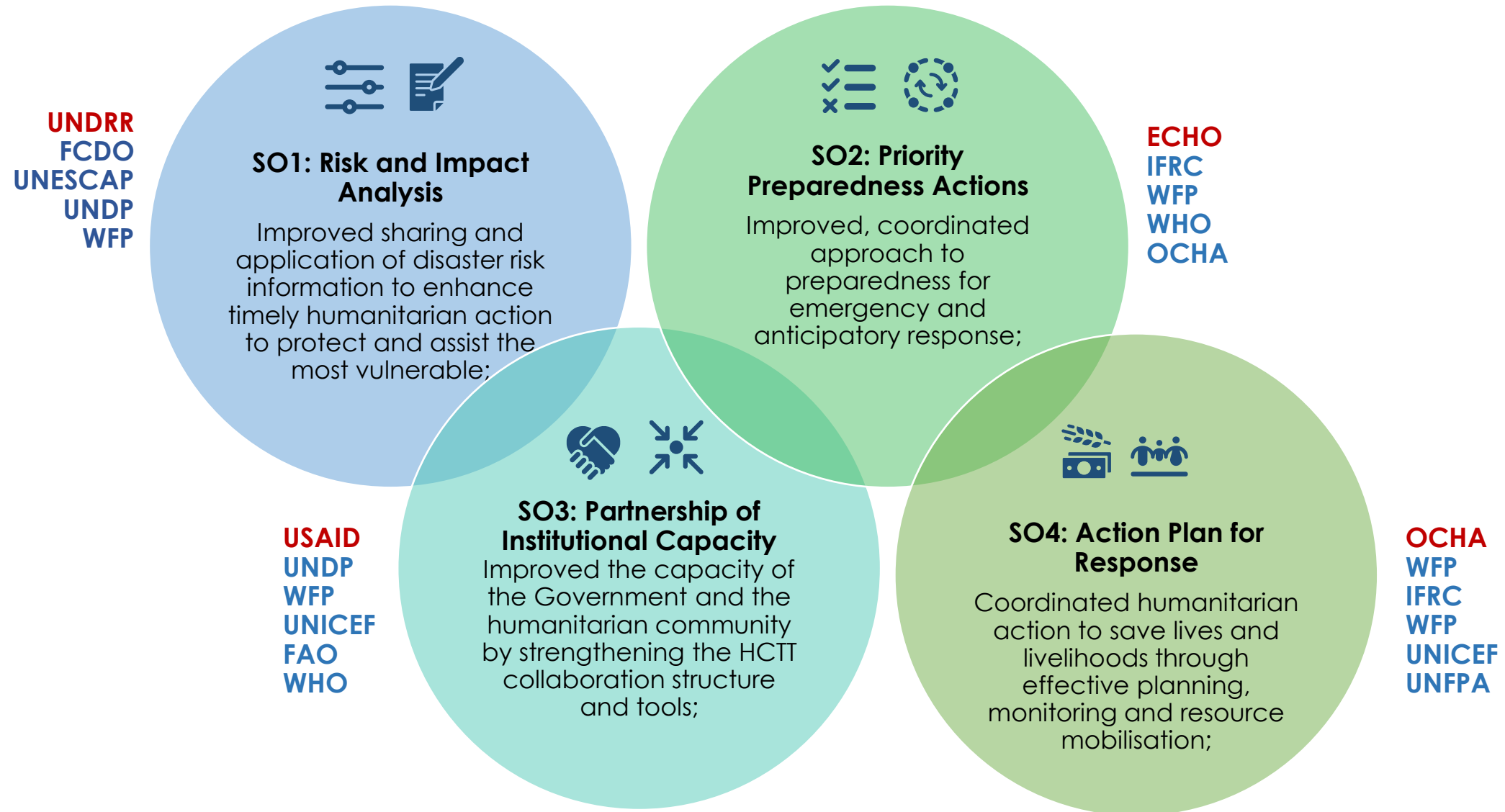


## What is HCTT Nexus Strategic (2021-2025)

- **Multi-year humanitarian preparedness and response strategy** for climate-related disaster developed to support and complement the NPDM 2021-25 and UNSDCF 2022-2026.
- **Evidence-based estimate of humanitarian needs in the disaster situation** on climate-related risks- flood, cyclone and landslide in Bangladesh.
- **Outlines key areas of improved collaboration** between humanitarian, DRR and development stakeholders can create mutually reinforcing strategies and synergies.
- **Humanitarian community's contribution to the Humanitarian-Development Nexus** but does not represent the entirety of nexus-related work in Bangladesh.
- **Supportive of the Sendai priority** to enhance disaster preparedness for effective response and the Grand Bargain commitments.

# Information: Risk and Impact Analysis

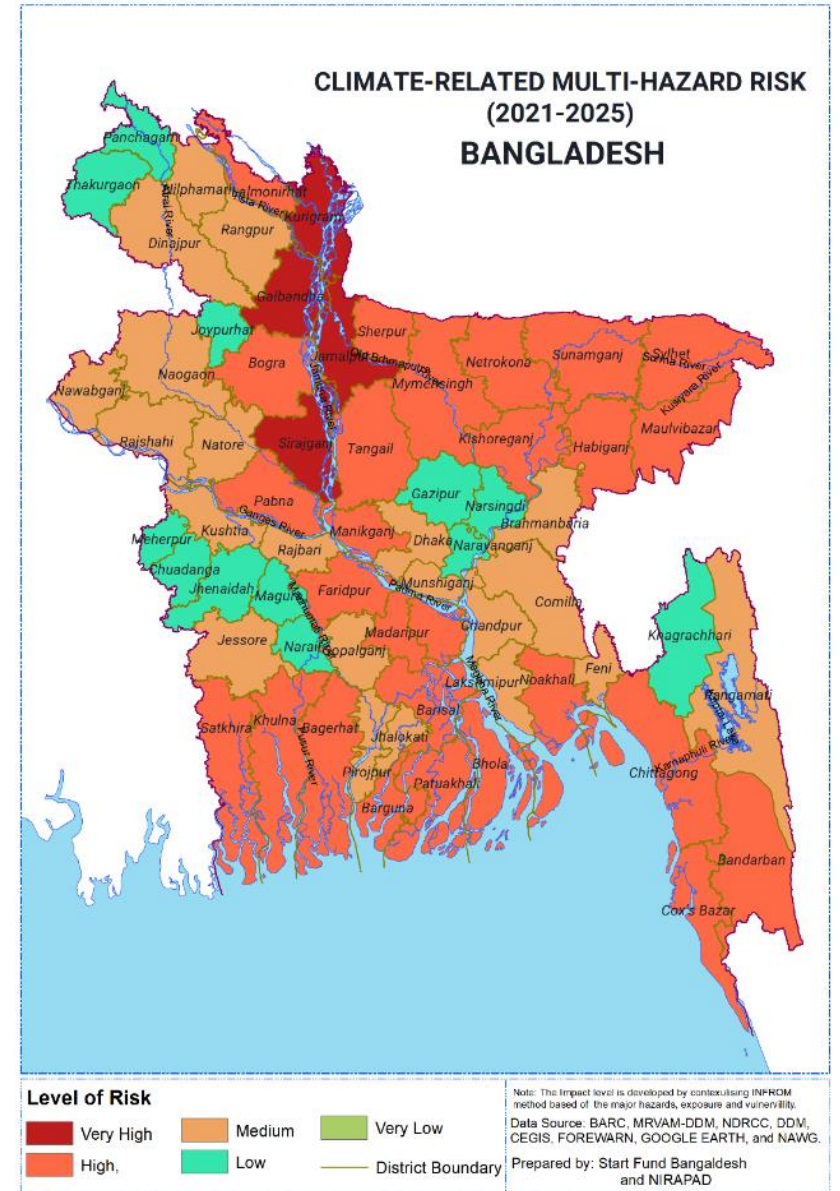
SO1: Improved sharing and application of disaster risk information to enhance timely humanitarian action to protect and assist the most vulnerable.

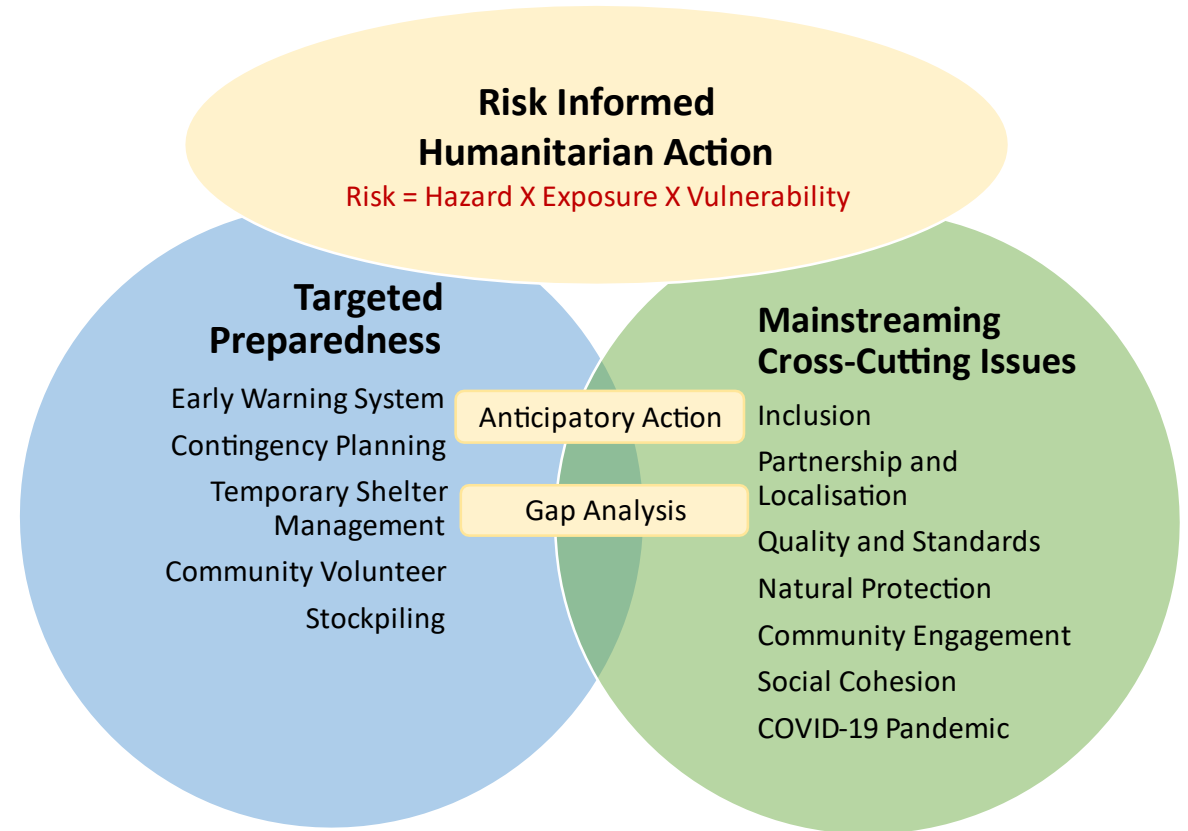

# Preparedness: Priority Preparedness Action

SO2: Improved, coordinated approach to preparedness for emergency response and anticipatory action.

- **Sectoral Gap analysis** in information management, preparedness, capacity and response based on the SPEED Approach.
- **ERP Approach** to ensure that operational readiness is in place to implement these activities identified through gap analysis.
- **Anticipatory Action support through CFP approach** by identifying the most appropriate activities that can mitigate against the potential impacts of a disaster.
- **Coordinated actions** will be promoted through the HCTT/cluster coordinated work plan with GoB and updated annually based on strategy.
- **Cross-cutting Issues** will promote seven elements for effective operations across the HCTT/cluster work.





# Capacity: Partnership and Institutional Capacity

**SO3: Improved the capacity of the Government and the humanitarian community by strengthening the HCTT collaboration structure and tools.**

## • Capacity Diagnosis and Planning

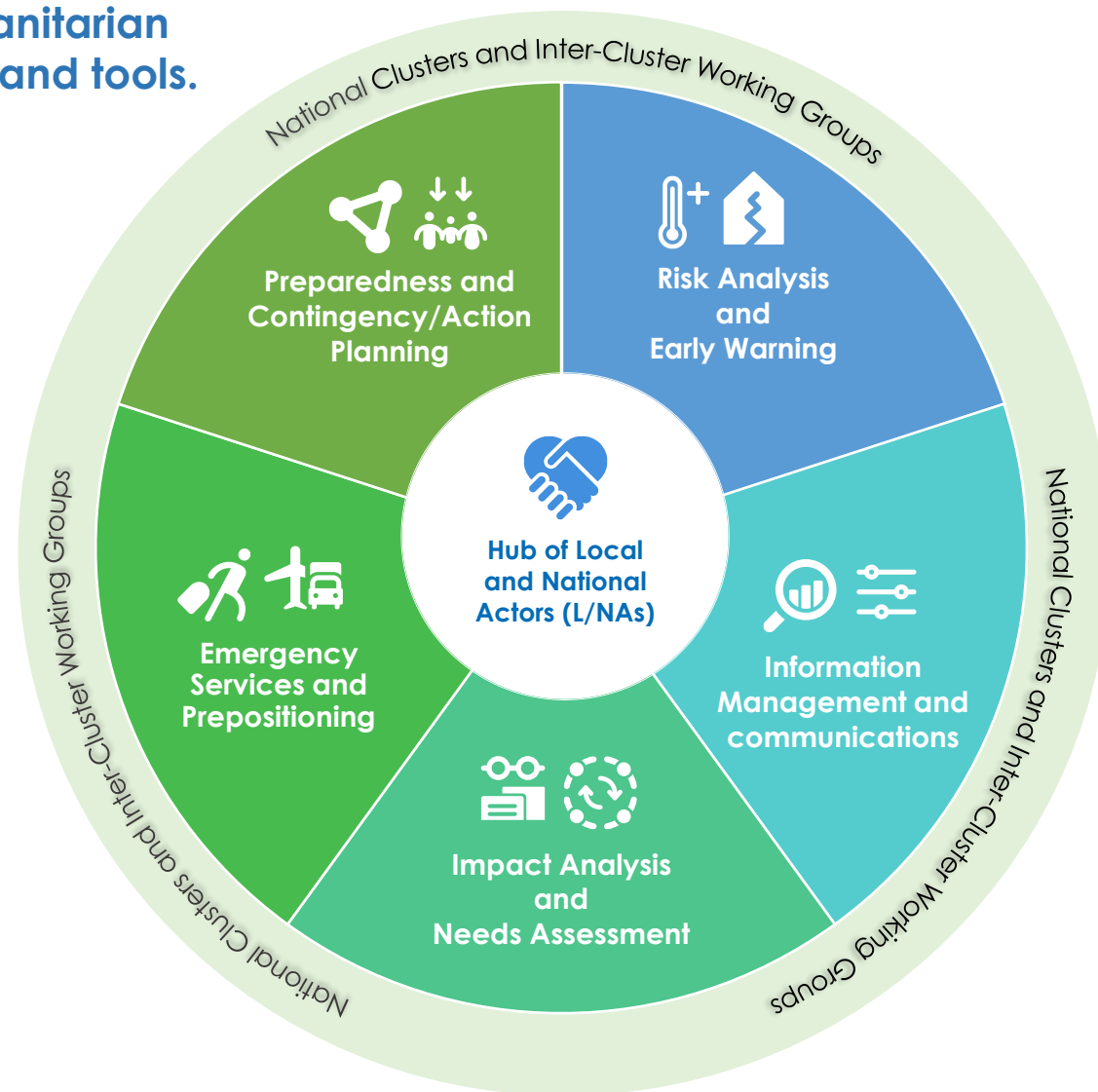
- Support the assessment of DMCs capacities to reduce disaster risk and manage disasters.
- Develop methodology, deploy multidisciplinary expertise in five key areas.
- Develop detailed implementation plans/programs for multi-sector and sector-specific capacity development for DMC.

## • Technical Supports through L/NAs Hub

- Support in establish L/NAs hub at divisional level based on priority and the availability of resources.
- Clusters and inter-cluster working groups, especially Localisation Technical Working Group (LTWG) will promote this hub to bridge the gaps between clusters at national level and DMC functions at local level.
- The clusters and inter-clusters working group will continue technical support to DMCs through the L/NAs hub with the facilitation, mentoring and feedback support.

## • Capacity Development

- The cluster and inter-cluster working group members will develop DMC member secretary (Operational Focal) and other relevant people's technical capacity in collaboration with L/NAs hub around the five key areas of DMC work as per SOD.

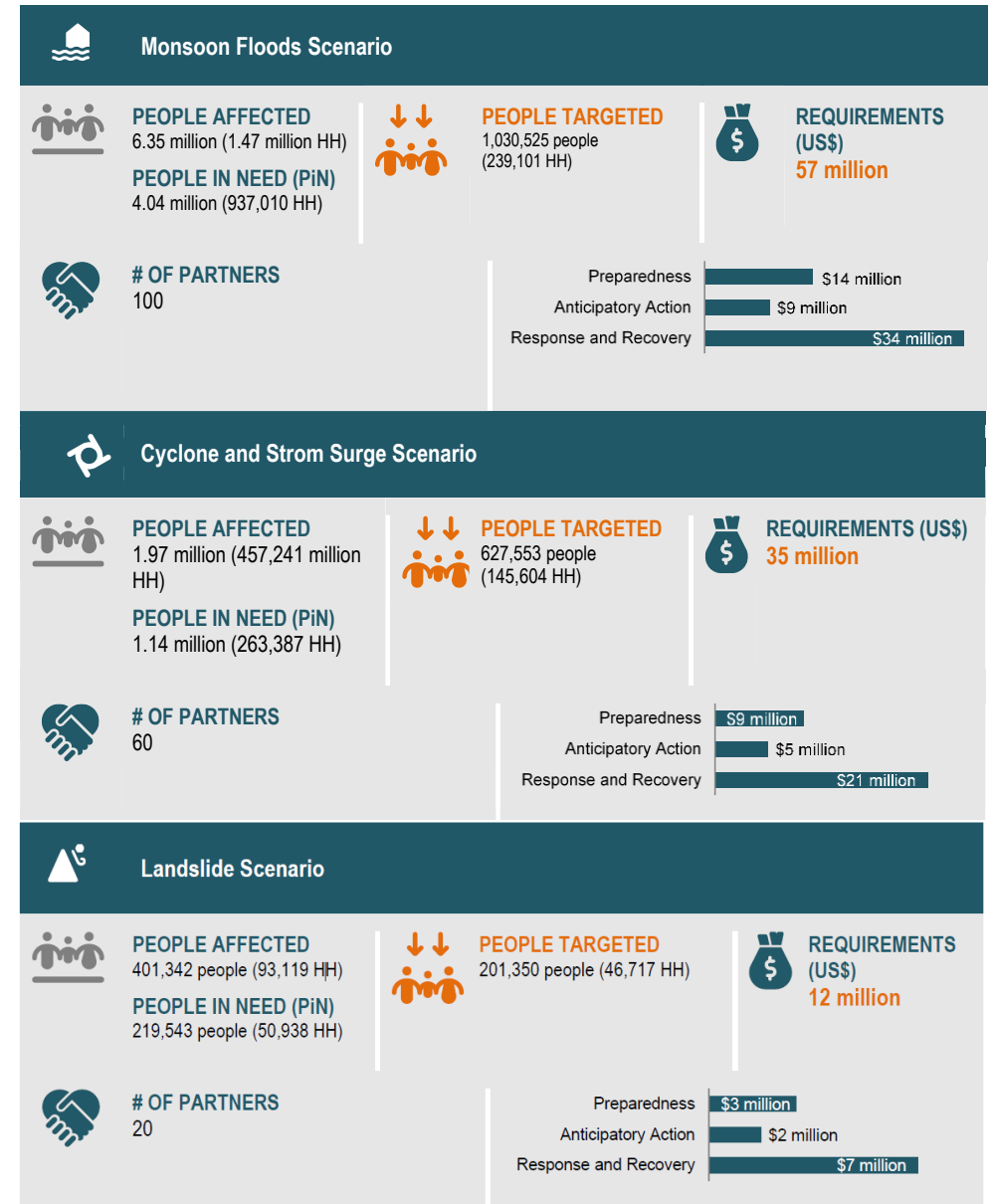


**Clusters Technical Support to L/NAs Hub to Promote Area-Based DMC Coordination Model**

# Response: Action Plan for Coordinated Response

SO4: Coordinated humanitarian action to save lives and livelihoods through effective planning, monitoring and resource mobilisation.

- **Thresholds for Response Activation** when the selected forecast exceeds an agreed thresholds for cyclone, flood and landslide which will explain later.
- **Annual Complementary Target and Budget for complementary assistance** calculate based on the lessons learned during the 2020 cyclone and monsoon flood response in the COVID-19 pandemic.
- **Cluster Priorities in Response** to improve speed, quality and volume of response with the assistance package which update regularly.
- **Develop HRP** if needed based on the joint needs assessment and agreement with GoB.
- **Monitoring strategy:** Support common accountability to affected population for monitoring and learning of the strategy.
