1. Partners' update.

- Planning to operate in 6 payams of Western Equatoria state. These include Mundri East, Mundri West 7 payams and Mvolo 7 Bomas.
- Promotion of vegetable gardening among the women.
- Running village saving and credit associations with the women groups.

Action Points:

- **Training the existing group on group dynamics.**
- **Purchase of saving boxes and the padlocks.**

CADA

- CADA is operating in Jonglei state, in Piech, Ayot and Fangak. They do not yet have operational project.

Pipeline.

- There is fund expected from GIZ to run the operations in the areas mentioned.
- The area of intervention will be majorly IGA activities, which aim at empowering women through voucher project. It was not yet clear during the meeting time if it will be voucher for work or for cash.
- The part of the project will also be implemented through cash grants.

Action Points

- **The target number of beneficiary will be established and communicated in the same forum.**
- **Follow up with GIZ to finalize the process of funding.**



LDA

The areas of operation include, Maiwut and Longechuk Counties in Eastern Upper Nile state.

- They were operating in 10 Payams of the 2 Counties, but currently with the conflict, operation is been put on hold.

Action Points:

CaLP Training

This training will take place in July.

Action Points:

Oxfam will communicate through the cluster to partners when it's confirmed. The date, venue and duration.

AOB

There was poor attendance from partners' organizations; this reason being some partners got involved in the current responses that of emergency and cholera. This therefore means that, if possible this meeting should be organised once a month such that partners will have enough to present, otherwise the interval of 2 weeks is not enough to give time for partners to report on achievement. In some cases some organizations would have not implemented activities.

Action Points:

- The partners requested for international organizations to step-up with advocacy so as the national organizations will be able to have funds for their operations.
- Other organizations like Oxfam should consider them (national organizations) in some of the responses within their areas of operations so



as to support build the capacity of their staffs in emergency operations.

- This meeting should be held in an interval of every one month to give opportunity for partners to report on completed and plan activities.
