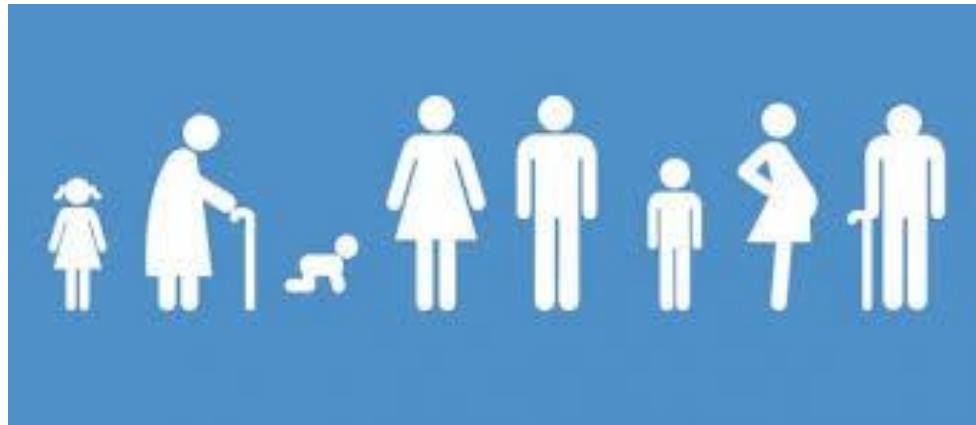

Purpose:

Women, girls, boys and men in different age groups have equal access to adequate and sufficient nutritious food at all times. This food meets dietary needs and preferences. The means of food production, sale and purchase, including agricultural interventions is equally accessible.
