



Response package harmonization:

In 2024, due to funding constraints, FSLC partners will provide the following rations:

- 70% of people's minimum caloric needs in Priority 1 counties.
- 50% of people's minimum caloric needs in Priority 2 and 3 counties.

For cash response:


- 1. Cash for food:
- The cost of the Food MEB is calculated every month by REACH (JMMI's report) and WFP.
 - In counties covered by WFP's LSR, FSL partners should align with WFP's calculation of the transfer value.
 - In other counties, FSL partners should align with JIMMI's report.
- The Food MEB is the starting point to calculate the transfer value that FSLC partners will use to plan their interventions.
 - For instance, if the ration is 50% in a given county, FSLC partners will use a transfer value equivalent to 50% of the cost of the food MEB calculated for the market of this county (or for the closest market of their intervention zone if the cost of the food MEB is calculated for several markets in the same county).





2. For Multi-purpose cash response:

- The cost of the MPC MEB is calculated every month by REACH (JMMI's report).
- It includes the same ration of food as in the Food MEB (70% of the food MEB in Priority 1 counties; 50% elsewhere)
- To avoid duplication risk, partners should no provide multi-purpose cash assistance to beneficiaries that are being assisted with food aid at the same time.
