2. Update on FSL response to IDP needs in GPAA	Next Steps				
<p>Following escalation of violence in Greater Pibor Administrative Area (GPAA) around Dec 24, the FSL cluster participated on a joint IRNA on Dec 31 and started a rapid response assistance to an estimated 17,000 IDPs sheltered in and around Pibor Town.</p> <p>WFP/CRS responded from 7 Jan onwards by distributing 15-day in-kind food rations to the IDPs. As of Jan 10, WFP/CRS have managed to distribute 96mt of food (cereals, pulses, oil) to 10,990 beneficiaries out of 17,000 (65%).</p> <ul style="list-style-type: none"> <li>• While the first phase of rapid FSL response comes to an end, the number of IDP is reported to continue increasing. <p>Historic high levels of food security in both severity and magnitude terms, at a time of shrinking funding forces the FSLC to optimize the allocation of resources:</p> <ul style="list-style-type: none"> <li>• Optimize logistics pre-positioning (presentation by Natalie Emery from the Logistics Cluster)</li> <li>• Avoid duplication and orientate FSL response in the most prioritized and under-covered counties, using a response GAPS Matrix: <ul style="list-style-type: none"> <li>○ ranking by FSLC priority: Priority 1, 2, 3, 4</li> <li>○ calculating the percentage of caseload coverage (planned response versus IPC3+ and IPC4+ populations)</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>- FSL partners to send their Service Request Form (SRF) or liaise with Logistics Cluster ASAP to prepare their pre-positioning. <a href="#"><u>Logistics Cluster pre-positioning presentation</u></a></li> <li>- FSLC Secretariat to send the response GAPS Matrix to partners</li> <li>- Partners to fill in the matrix with their planned CO1 activities for 2023</li> </ul>
