Guiding Principles for Humanitarian Food Assistance (CO1) in 2024	Next Steps / Action Points
 Targeting prioritization Provided guideline on CO1 (Food Assistance) to coordinate within the cluster partners for geographic and beneficiaries targeting in the context of reduced resources as there is not enough resources to cover the 7.1 M people in need under Food Security and Livelihoods Cluster. Based on WFP's lean season response plan (GFD) for food assistance in 2024, counties in IPC 4 not covered by WFP are Aweil West, Rumbek Center, Yirol East, Yirol West, Awerial, Budi and Renk). Partners are encouraged to cover these counties except Renk. Until further notice, as decision on what is the adequate response in Renk is being reviewed by HCT (Renk being the main entry point for the returnees from Sudan being congested and to avoid assistance being the pull factor). Response package Harmonization: Response package for food assistance shared in line with ration size and number of days to be covered. For cash response (cash for food) - refer to the calculation used by WFP and JMMI (REACH) report to calculate the transfer value which is equivalent to 100 % ration. Adjust this depending on the priority counties with 70% or 50% ration. 	 Partners are advised to cover the counties or caseloads (in case of partners operating WFP priority locations) that are not covered by WFP for effective targeting. Partners are advised to wait till the HCT's decision on the response modality to be applied in Renk. Guiding principles for HRP 2024 – refer to the targeting prioritization Partners are advised to provide same ration size based on the prioritization in counties not covered by WFP. • 6 counties in priority 4 will not receive GFD but other ACL, nutrition	
support.
