







Nutrition Beneficiary Referral Key challenges





□ Low Referral of households with SAM and MAM under-fives and PLWs to humanitarian food and cash assistance
 □ Duplication/ overlaps in assistance :Nutrition to Relief referrals data duplicate.
 □ Delay of Nutrition Beneficiary registration into Scope system since 31st March,2023 due to FLA and new TSFP and Relief partners selection process.
 □ In adequate resources: like Scope Equipment was the main challenges of not enrolled all the nutrition beneficiaries referred into the WFP relief partners.
 □ Capacity related challenges: CP capacities and meeting high quality standard program implementation was also another challenges
