Welcome

1. Mr. Konabe welcomed all participants to the cluster meeting.

Tari Emergency Response

- 2. Ms. Sikas-Iha provide the following update to the cluster:
 - a. The tribal fighting resulted from a murder that occurred in mid-January 2021 at Pi Nakia village of Tagali LLG, Koroba Kopiago, Hela Province.
 - b. On 27 January 2021, tribal fight broke out in Mulipi community, Tari-Pori, as relatives of the deceased started killing people in the community indiscriminately.
 - c. As of 8 February, the number of displaced people is now over 2,924 persons, including women and children. Of these displaced persons, 430 households are displaced.



- d. To date, 21 people are confirmed dead.
- e. Temporary care shelters were provided for displaced persons and families in the following areas: Hoiebia (primary school classrooms and UCHR community centre), Kikita village, and Tari Town (Tari Women's Guest House and Nazarene Church)
- f. Sickness have been reported among those displaced and hundreds were injured.
- g. FAO has provided relief food items to the displaced persons in the care centers and communities. The food relief items include food baskets with dried goods and fresh produce from local fresh producers.
- h. Other coordinating partners and UN agencies including United Church Hela Region, UNFPA, UN Women, IOM, UNICEF, World Vision, DFAT, Palladium, ExxonMobil and others have provided relief support and services to the Tari emergency.
- i. Police and PNGDF personnel have been deployed for security on the ground. The tension till remains high.

Brief on effects of COVID-19 and other shocks on PNG's food economy

- Dr. Schmidt from the IFPRI provided a PowerPoint presentation of the IFPRI research report "Effects of COVID-19 and Other Shocks on Papua New Guinea's Economy: A Multi-Market Simulation Analysis"
 - a. The study uses a multi-market simulation model of the PNG food economy that explicitly includes production, consumption, external trade and prices of key agricultural commodities to quantify the likely impacts of a set of potential shocks on household welfare and food security in PNG
 - b. The paper models economic shocks simulated across 20 household groups in the four PNG regions; rural, urban and metro households; and poor and non-poor households.
 - c. In summary, the research report states that PNG is not a stranger to unexpected shocks, especially shocks (El Niño, Cocoa pod borer, African Swine Fever, etc) that directly affect agricultural production. PNG has the potential to build from COVID-19 pandemic to pilot and identify a suite of targeted safety net programs that can address food consumption vulnerability in different regions of the country. However, PNG lacks important and up-to-date data on household production and consumption. Furthermore, greater investment in market infrastructure would lower the cost of trade and enhance food security by minimizing the effects of local production shortfalls.

Updating of COVID-19 4Ws for February

- 4. Ms. Sikas-Iha informed the cluster of that the Food Security Cluster Secretariat will send out the COVID-19 4Ws template to the cluster members for them to populate and revert before the deadline of 22 February 2021.
- 5. The collection of the COVID-19 4Ws is coordinated from the PNG Disaster Management Team (PNG DMT).

COVID-19 Contingency Plan

- Ms. Sikas-Iha informed the cluster that the Contingency Plan is currently under development by DMT and respective clusters are required to provide their inputs in terms of response, recovery, plans, etc, to their cluster heads to report to DMT.
- 7. The deadline for cluster inputs to the Food Security Cluster is 6 April 2021.

La Niña Observation Tool

- 8. Ms. Sikas-Iha informed the cluster that DMT La Niña Observation Tool will be sent to cluster agencies to provide their inputs.
- 9. The La Niña Observation Tool provides a monthly update of the effects/impacts on rainfall, temperatures, water, food crops, food prices and market trends, flooding, health and nutrition.
