

1 - Contextual Update and FSL Situation

- Couple of states government declared state of emergency from 1 May for a month due to insecurity and to control supply movement targeting and smuggling to control the movement of essential goods from capital of the states to the localities to maintain balance.
- Camps establishment is limited and not functional in some places if established as people are accommodating with their relatives. Transitional locations are preparing in some states for this purpose.
- Increasing of prices of food commodities and lifesaving needs.
- Wheat flour and Sorghum is available in Easters States and but it won't be long enough to last. FSTS to monitor markets.
- Fuel is available at the moment again but not sure for how long it will last.
- Banks are not operational well due to network problems even Bankak is not functioning as usual.
- FAO and WFP is planning to conduct rapid assessment to inform the response.
- Agriculture support in terms of provision of Seeds needs to be provided.
- The state ministry will support land preparation and avail fuel for the rainy season.
- FSL partners don't have emergency stock available as they in DODCSECURATY early recovery and development interventions.



2 - HRP Revision and Financial Appeal

- Before the conflict erupted, humanitarian needs across Sudan had reached with 15.8M people—about a third of the total population—requiring humanitarian assistance, according to the **2023 Humanitarian Needs Overview (HNO)**.
- Considering the recent Conflict Crises, Humanitarians are moving ahead to revise <u>2023 Humanitarian Response Plan</u> (HRP) to reflect the additional needs and operational developments.
- FSL Sudan was already identified 11.7M PiN for humanitarian response under HRP 2023 with the target of 8.2M of the most vulnerable, but these figures are expected to be higher now due to the ongoing conflict, and the consequent price increase of food, fuel, water and other essentials.
- FSL partners are aiming at providing life-saving food assistance to affected people and resume and maintain assistance to targeted caseload pre-crisis.

Calculation Methodology for PiN & Target

WFP figures – 19.1M (PiN) RBN Report based on forecast based on price increase

Food Security Analysis and Forecast

FAO figures – 18.7M (PiN)

- IPC Phase 2 figure is: 17,580,000,
- 40% of the 17,580,000 is: 7,032,000
- 11.7M + 7M = 18.7M People in Need



2 - HRP Revision and Financial Appeal

FSL Sector proposed Figure:

- FSL Sector will take the highest figure as PiN 19.1 (which accounts and includes crisis effects: displacement, price hikes, etc).
- FSL Sector is still working to define final target figures based upon operational capacity and the data received from partners.
- The target will be based on previous FSL target (8.2M) + displacement data + operational capacity by partners.
- FSL Sector will adjust the PiN, Areas and Costing with addition to last HRP.

PiN & Target Calculation Methodology

- Financial appeal will eb launched after the revised HRP.
- Previous projects will remain same under HRP with no change.
- New FSL partners can submit their proposals for the new areas based upon their operational capacity.

3. Food Security Analysis and Forecast (May 2023) - WFP

- The latest CFSVA indicates that 34 percent of the population, amounting to 16.1 M people, are food insecure during Q1 2023.
- The highest prevalence of food insecurity was observed in West Darfur (56 percent); West Kordofan (56 percent); Blue Nile (50 percent); Red Sea (49 Percent); and North Darfur (47 percent).
 Around 30 percent, amounting to 14.8 million people, could not afford one
- LFB.
- This may increase to 39 percent, over 19 M people, in the next 3-6 months, if the current conflict continues.
- Over 18 M unable to afford the LFB.
- Assumption is that the price of the LFB may increase to 500 SDG in the coming months.
- Findings of CFSVA presented at next FSL meeting, report published in coming weeks.

4 - Operational Plan and the way forward/Program adaption

FSL Sector Capacity

- FSL fully operational with FSL coordinator temporary working remotely and IMO capacity (one IMO supporting remotely and one IMO surge under recruitment)
- FSL has focal point appointed by CLAs (WFP and FAO) in each State. FPs in eastern states are reachable, FPs in Darfur and other parts of the country difficult to reach.
- FSL partners are resuming operations where possible mainly in easter States (Kassala, Gedaref)
- Since restarting food distributions last week, WFP has reached more than 42,000 refugees and IDPs across Gedaref, Kassala and White Nile with dry food rations
- FSL partners has approximately 36 partners.
- FSL PIN 11.7M Target 8.2M reaches SO1 (food assistance) for Q1 2023 is 951,458 reached SO2 (Livelihoods) for Q1 2023 is 1,484304
- FSL HRP 2023: 437 M ask 153 M funded (35%)

- Security situation
- Protection and GBV Issues
- Humanitarian access in Western States and Khartoum
- Connectivity (limited)
- Liquidity crisis: limited availability. BOK is now confirmed to work in Gedaref and Gezira too, but only limited services: BOK in Gadaref is providing services of depositing and withdrawing cash directly through the bank desks (SDG and USD). Bankak is limited only to transferring SDGs from account to another, but the network is always weak.
- Price hikes. Prices of food commodities increased over 200%
- Limited availability of fuel.
