1.	Welcome, Introduction and Opening Remarks The meeting was opened by the Deputy Sector coordinator and followed by self-introductions. The Chair sent apologies due to other urgent government meetings.	
2.	 Review of action points and approval of minutes of the previous meeting (5 min) Sector to organize a proposed recommendations and lessons Learned workshop between partner involved in micro/kitchen/backyard gardening (including FAO, AAH, NRC and SCI) - Pending FAO to share LGA-level post-harvest assessment findings for Borno State – Pending Sector to share Seed Voucher and Seed Fair guidance notes with partners for further comments – pending Partners to provide the pending information including variety of inputs to be distrubted and also detailed information up to ward and community level, including the households targeted and distribution dates - Ongoing. Sector to facilitate partner coordination in "hot spot" locations where there are multiple seed distribution partners - Ongoing. Sector to share a map indicating seed distribution plan by location – Only the land access map was shared. A map of seed distribution completed will be produced. 	
	After the review, the minutes of the meeting held on 30 May was adopted.	



3.	Updates on 2019 rainy season seed distribution by partners and discussions	
	Challenges faced so far at the start of the distributions	
	• It is expected that during Eid period, the seed distribution activities will slow down,	
	therefore partners should enhance sensitization.	
	Some vendors in some areas ran out of stock. This was resolved by ensuring more	
	than 3 vendors are availabel in the same location.	
	Partners had a discussion about the consolidated seed distribution excel sheet. The	
	sector led the discussions on assessing locations/communities where there would be	
	likelihood for overlapping. Partners mentioned they have been coordinating in those	
	areas where there are multiple partners. Sector encouraged partners to pay more	
	attention to hot spot locations including Monguno, Damboa, Jere, Kaga, Konduga,	
	Mafa, Ngala, Nganzai, Damaturu.	
	• There are LGAs that are likely to end up with more than coverage. For instance,	
	Monguno, it is unlikely to have 23,694 HH with access to land in the current situation	
	(knowing the assessed population of Monguno town is estimated to be 36,879HH).	
	The Monguno FSL coordination group is supporting the coordination efforts at field	
	level.	
	How partners are ensuring beneficiaries have access to land. According to partners:	
	By asking the heads of household whether they planted the previous season and	
	whether they currently have land.	
	Talking to Bulamas and other local leaders on estimated availability of land	
	Consulting with government extension workers from the ADP in field locations	
	Measurements of the land should be done to ensure that the seeds distributed	
	will be sufficient for the land.	
	Where possible make random visits to land mentioned by a few beneficiaries. A	
	partner mentioned that this process takes time and requires patience.	
4.	AOB:	
	To ensure beneficiaries do not consume/sell seeds, some seed distributions have	
1	been complemented with food assistance. The sector further encouraged partners	
	to continue sensitization so that beneficiaries not to misuse seed.	
	Regarding fertilizer movements, the restrictions still stand.
