2. IDPs responses, updates and gaps.

FSAC presented the gap at IDPs site in Aden, Al Dhale'e and Abyan governorates as per the table below;

- In Khanfar district of Abyan governorate, NRC manages only six IDPs sites while IDPs EXu manages
 35 IDPs sites and the overall food gap among all the sites reached to 1478 HHs who claimed not receiving food assistance. This should be subjected to need assessment
- Give Directly is planning to begin its intervention in July 2022 and looking for ensuring any significant gap proposed to arise from that month. FSAC in coordination with CCCM, are going to visualize any expected gap based on the actual plan of other partners.
- CARE will confirm to FSAC regarding extension of its ongoing intervention in the IDPs sites in Aden.
- SI is planning to carry out an assessment in the IDPs sites managed by NRC in Khanfar district, Abyan governorate due to last alert raised by FSAC.
- NRC (CCCM Partner) pointed out to considerable gap in the IDPs sites in Tur Al Baha district, Lahj governorate specifically Al Sharair and the Hospital IDPs sites.
- Horizon is providing emergency food assistance to 100 HHs in Al Soamea'a IDPs site in Al Malla district, Aden governorate. The plan will be shared with FSAC.
- NMO still have three remained cycles of emergency food assistance response in Al Dhalea and Qatabah districts.
- CARE has a plan to target 185 HHs in Qatabah through provision of emergency food assistance for six cycles. The distribution is planned to start in May 2022.

Action Point:

- FSAC in cooperation with Acted (CCCM Partner) to share the updated gap at IDPs sites in Aden with Give Directly.
- CARE to confirm to FSAC the status and details of its ongoing intervention in the IDPs sites in Aden and particularly in a case of extension to its interventions.
- > Horizon to share its distribution plan with FSAC.



> CARE to update FSAC about its planned intervention in Qatabah district.

3. Regular response updates (achievements, gaps, and challenges)

- FSAC highlighted the districts with considerable gap in Aden and Al Dhala'a governorates as follows; Aden (Al Mansura, Al Mualla, Ash Shaikh Outhman, Attawahi, Craiter and Dar Sad districts) and Al Dhale'e (Al Dhale'e,, Al Husha, Al Hussein, Ash Shu'ayb and Qa'atabah districts).
- The gap at sub-district/villages of Aden governorate is being identified to highlight the areas, which should be considered for coming interventions of partners. The same exercise is planned to be perused in other concerned districts.
- FSAC highlighted set of partners, which have a plan of food assistance distribution for one-off cycle in coming month of Ramdan as follows; SIF and Yemen Aid in Lahj governorate and KSR, Gift of the Givers, Yamani, Read Organization and HRF in Aden Governorate.

Action Point:

- All pertinent FSAC partners, which planning for one-off cycle of food assistance distribution to ensure prior coordination.
- > FSAC to share detailed gap at sub-district/village level of Aden governorate.

4. 2022 Yemen IPC Snapshot

- FSAC presented the 2022 Yemen IPC snapshot highlighted the key-points including the following:
 - > Acute Food Insecurity: June December 2022
 - IPC 3 and above: 19 Million People (7.14 Million people in phase 4 and 161,000 People in Phase 5)
 - 233 of the 333 districts (45 percent) are currently classified in IPC Phase 4 (Emergency),



- Acute Food Insecurity: June December 2022
 - IPC 3 and above: 19 Million People (7.14 Million people in phase 4 and 161,000 People in Phase 5)
 - 233 of the 333 districts (45 percent) are currently classified in IPC Phase 4 (Emergency),
- Key drivers: Conflict, Economic crisis , Reduced funding for humanitarian assistance, Reduced access to basic services and Natural hazards
- Recommendations: Ending the war and economic stabilization, Provide life-saving humanitarian assistance, Provide livelihood support and diversification, Improve inter-sectoral programming and Strengthen monitoring and early warning systems

5. Updates on the Prioritized Rehabilitation for Community Assets – New Template

- FSAC developed the new tool for capturing partners' initial information about the Prioritized Rehabilitation schemes for Community Assets.
- Some of partners shared their inputs including, FMF, FMF, CARE, BCFHD, VHI, SFHRP and SHS. However, there is still a need for exploring further inputs of other partners to ensure having a comprehensive information covering all districts.
- The new deadline was identified to give partners some rough time to gather all requisite inputs. The deadline is 14 April 2022.
