# 1. Review of last Meeting Action Points

ADRA to share initial details related to its new intervention in Lahj, Abyan and Al-Dhale'e governorates and FSAC to send details of gap for possibility of covering the gap by ADRA intervention

Ongoing: ADRA already met with FSAC and shared initial information on its plan and targeting districts.

> WFP to keep FSAC updated about the timeline of distribution.

Ongoing: WFP updated FSAC on the cash assistance distribution in Aden, which started in the 4W of June.

FSAC and Give Directly to confirm the status of Al Hofra and Al Farsi IDPs collective sites in terms of gaps and response

Done: Give Directly is going to target Al Farsi IDPs collective site while FSAC is exploring for other partner to cover Al Hofra site.

Partner who did not share yet its intervention inputs through FSAC Sub-district/village level mapping, to share by 21 July 2022.

Ongoing: Some partners did not share their mapping inputs yet.

- WFP to update FSAC about timeline of distribution in Al Dhale'e and Lahj.
  Not yet: WFP did not begin the emergency food assistance distribution in Al Dhale'e and Lahj and so far, the timeline of distribution is not assured yet.
- Partners involved in distribution of meat activity at Eid Al Adha, to coordinate with each other and send to FSAC all relevant information

Done: Most of the partners informed FSAC and each other about their plan of distribution of meat at Eid Al Adha which was conducted for one-time.



# 2. IDPs responses, updates and gaps

- FSAC presented the gap at IDPs site in Aden, Lahj Al Dhale'e and Abyan governorates as follows;
  - Lahj governorate: Gap exists in Tuban and Radfan. The gap at sites managed by DRC is 869 HHs and 342 HHs at IDPs sites managed by NRC.
     IDPs Sum reported 1147 HUs in feed can among 20 sites
  - IDPs Exu reported 1147 HHs in food gap among 20 sites
  - Aden governorate: 663 HHs in the IDPs sites of Al Buriqah are in food gap and 114 HHs in Dar Sa'ad
  - Al Dhale'e governorate: Gap is 537 HHs at sites (437HHs only in Al Dhale'e). This is under registration of ACTED and to be confirmed.
  - Abyan governorate: the gap reported by IDPs EXu is as follows (1500 HHs in Khanfr district, 600 HHs in Zinjbar district, 1500 HHs in Sirar district and 30 HHs in Rosod district).
- Gift of the Givers in partnership with DRC, provided food assistance to around 850 internally displaced households in IDPs collective sites in Tuban district. DRC was in charge to transport all food baskets rendered by Gift of the Givers from Aden to Lahj and this response was for one cycle.
- IDPs EXu shared with Give Directly, the updated figures of IDPs among the collective sites in Aden and is going to start registration in last week of July 2022. Give Directly is going to target Al Farsi IDPs collective site in Al Buriqa district, Aden governorate, hence Al Hofra IDPs collective still lacks of any partner from this month and so far, no partner has confirmed any planned response there.
- Acted CCY is going to register 540 HHs among the IDPs collective sites in Al Dhae'e district, Al Dhale'e governorate and based on the scoring given to the vulnerability condition of the HHs, the enrollment and number of cycles of distribution will be identified.
- ADRA is going to target two districts in Abyan governorate, six districts in Lahj governorate and three districts in Al Dhale'e governorate as outlined in the table below;

The first cycle of emergency food assistance distribution is planned to begin in September 2022. FSAC emphasized on the need to intervene in Al Dhale'e city of Al Dhale'e district as well as MoPIC has raised the same concern requesting the partners to consider the city of Al Dhale'e for any coming intervention in the district.

- Heavy rains hit some of IDPs sites in Al Dhale'e, AL Hussain and Qatabah districts, and many households were affected losing food/non-food/shelter items. As reported by CCCM, 92 HHs are deemed the ones who are in need for food assistance. FSAC already shared the alert with all partners to cover those needs urgently.
- The IDPs in Al Haj Saleh building IDPs collective site received a threat to evacuate the building and were given six days for preparing themselves and leave the site and thus, CCCM asked for any cash assistance to be provided to cover the expenses of transmission. FSAC highlighted that the assistance provided by FSAC partners ascertains certain objectives related to cover food gap,



but this should be discussed with Protection and Shelter clusters who are meant here regarding this eviction threat and relevant assistance.


• CARE is carrying out verification activity to all HHs at IDPs collective sites and host communities. The first cycle is supposed to begin on 15 August 2022. The final selected areas will be shared later.

#### **Action points**

- FSAC and ADRA to discuss the intervention in Al Dhale'e and possibility to include also Al Dhale'e city within targeting areas.
- ACTED (CCCM partner) to share the list of IDPs affected by the flood and to do a cross check with CCY team to exclude the people who are registered in the beneficiaries list of ACTED.
- FSAC in collaboration with ACTED to update the gap figures in the collective sites of Al Dhale'e.

# 3. Regular response updates (achievements, gaps, and challenges)+ one off distribution

• FSAC highlighted the districts with coverage less than 100% under emergency food assistance response as per the chart below



- Yemen Aid is going to implement livelihood project in Tuban district which includes several activities such as providing greenhouses and provision of seeds (tomatoes and paper).
- CARE has a planned livelihood intervention in Lahj and Abyan and shared its initial details with FSAC as follows;
  - Supporting 1200 Farmers: (500 HHs in khanfer, 400 HHs in Tuban and 300 HHsTour Al-Baha) will be supported by onions and one of the proteins products ( (Cereal Peas, cowpeas, beans, Sesame) according to the targeted land nature. In addition, the farmers will be supported by cash plus for three months (\$50/HHs)



- Supporting 500 fishermen in Khanfer( Shokrah), and fishers (mostly men for production, and women for marketing) will be supported by fish kits and cash plus for three months (\$50/HHs)
- Supporting 400 HHs pastoralists (80% women, who raise small ruminants); supported by chickens for egg production and as a source of protein.
- Supporting 855 HHs Short term cash transfer support for most vulnerable HH experiencing undernutrition to address immediate nutrition needs.
  Supporting 400 HHs with Vegetables Seeds for Homestead Gardens.
- Dorcas Aid International is waiting for sub-agreement to be approved for launching its intervention including some livelihood activities such as developing solar oven cooking stoves in Al Dhale'e. All of details will be discussed with FSAC later once relevant agreements are approved.
- Horizon and Yemen Aid in partnership with NRC are going to implement livelihood activities in Lahj specifically agriculture activities. They're embarking in coordination for all agriculture support and the selected areas will be shared once they're finalized.

#### Action points

- Any partner has a fund and capacity and proposes to cover the districts reported with gap, to inform FSAC.
- All partners which are planning to implement new livelihood activities, to include all relevant details in FSAC mapping.
- Yemen Aid to coordinate with CARE regarding its livelihood intervention in Lahj to avoid duplication.
