2. FSAC regular response update and challenges

A. Partners updates

- **Food Security:**
- 801,936 individuals have been supported with emergency food assistance in Hadramout, AL Mahrah, Shabwah and Soqatra governorates.
- For the Emergency Food Assistance (EFA) and based on the FSAC target for 2022, gaps are as follows:

- 134,314 individuals have been accumulatively assisted with livelihood assistance since January 2022 in Hadramout, AL Mahrah, Shabwah and Soqatra governorates.
- For **CFW & Livelihoods Activities** in Marib and based on the FSAC target for 2022, gaps are as follows:

 - Response to the 418 IDPs in Al Ghaydhah, Al Masilah and Haswin districts of Al Mahara governorate on monthly bases.

a) Conditional Cash Transfer (CCT):

 Based on the General Principles of CCT Programmes in Yemen n. 1, 2, 3, the monthly CCT values should be the following:



o **South:** 126.500 * 110% = 139.000 YER

o **North:** 70.500 YER * 110% = 77.500 YER

- b) <u>Unconditional Cash Transfer guidelines</u>
 - Harmonized transfer values of the FSAC MFB for a household of 7 members will be:
 - South: YER 126,500/household/month (\$123)
 - North: YER 70,500/household/month (\$126)
