### 1. Review of previous meeting action points

- FSAC sub-cluster to follow up with SCMCHA and OCHA on partners' requirement to continue their soft implementation.

## 2. FSAC Partners update: key achievements, gaps, and challenges

- FSAC sub-cluster coordinator presented the achievements of partners in Hudaydah hub for December 2022 and plan for January 2023 indicating as follows:

### A. Emergency Food Assistance

**Hudaydah:** 1.372.356 individuals have been assisted with monthly emergency food assistance (EFA) within 24 districts. The key actors carrying out EFA in August are WFP implementing partners (IRY, VHI, DRC, NFDHR, SFHRP BFD, and non-WFP implementing partners (Direct Aid, CARE and SCI).

**AL-Mahwit:** 353.243 individuals have been assisted with monthly EFA within 9 districts. This is implemented by 3 active FSAC partners (SFHRP, YFCA/WFP, ZOA)

**Raymah:** 163.996 individuals have been assisted with monthly EFA within 6 districts. This is implemented by 2 active FSAC partners (IRY, RI).

### B. Livelihoods Assistance

**Hudaydah:** 8.193 individuals have been assisted with CFW and assets restoration assistance. Key FSAC partners are SMEPS, NFDHR, UNDP, SFD, CARE, and FAO.

**AL-Mahwit:** In AL-Mahwit, 4, 627 individuals have been assisted with CFW and assets restoration assistance. Key partners are UNDP and FAO.

**Raymah:** In Raymah no update.

- **Partners key updates:**

- WFP partners are launching into the food distributions and will be reflected in the FSAC IM tool.
- Ongoing Projects for the emergency food assistance by the Direct AID, SCI-IRY-ZOA-ICRC/YRC and CARE and will be reflected in the FSAC IM tool.
- Ongoing Projects for the livelihoods by the BFD -IRY- NFDHR- CARE-RDP, SMEPS and SFD will be reflected in the FSAC IM tool.
- BFD are implementing the FFT project at 450 HHs in Az Zuhra'a- Bajil and AL-Marawi'ah districts in Hudaydah, 500 HHs FFA in Bajil in Hudaydah. In addition to that BFD will support 245 HHs FFA and 65 HHs FFT in Melhan district in AL-Mahwit. This is going to be reflected in the FSAC IM tool
- Direct in Coordination with FSAC completed the first food distributions in Hudaydah city ( AL-Hali- AL-Hawak and AL-Mina) targeting 2,400 HHs by food distribution.
- ICRC distributed one off food to 2000 HHs, in Az Zuhra'a district. FSAC carried out the cross check and found that 249 HHs are found in WFP list and 12 HHs found in CARE list under CFW list.
- SCI in close coordination with FSAC crosschecked the lists for 1200 HHs in Hudaydah city to provide cash transfer at 6 rounds. The cross check findings found that 25 HHs are found in WFP list.
- SCI has completed the 3rd (last) round distribution of UCT for 93 HH under BHA-RRA funded project.
- GFFO in both Bajil 1000 HHs and Bait AL-Faqiah 1000 HHs. The first round has already done.
- Pure hands is continuing the coordination to their plan to support 100 HHs for almost 12 rounds a year. FSAC will support to guide pure hands to select 100 HHs from the IDPs sites. This has to be done in coordination with the CCCM and FSAC in Hudaydah hub. So far Numan IDPs site already selected in Az Zuhra'a district.

- **Gap analysis** of emergency food assistance and Livelihood-related activities in Hudaydah hub is presented during the meeting and summarized in the below table:

### Action points

- FSAC S.N.C.C explained that areas with high needs and gaps are prioritized e.g. hosted big number of IDPs, classified in IPC 4, IFRR and flood affected districts.
- FSAC S.N.C.C is to kindly coordinate with partners who do not yet share their mapping for 2023 and does the final touch for the updated FSAC mapping.
- FSAC partners with key concerns on technical aspects for both emergency and livelihoods assistance are encouraged to communicate with FSAC.

### 3. IDPs Response and Gaps

- The FSAC S.N.C.C in coordination with the CCCM Sub-national cluster coordinator presented the gaps for the IDPs sites in Hudaydah- AL-Mahwit and Raymah governorates. This is considered as potential target planning in 2023.
- FSAC requested FSAC partners to consider the gaps in IDP sites and ensure proper coordination while the planning stage on the targeting and location selection.
- Coordination will provide more understanding for the gaps in either emergency food assistance or livelihoods.
- Better guidance for the selection of locations that prioritized in terms of needs and is to avoid any potential duplication and or overlapping. Gaps in IDPs Collective sites are presented in the meeting as follows:
