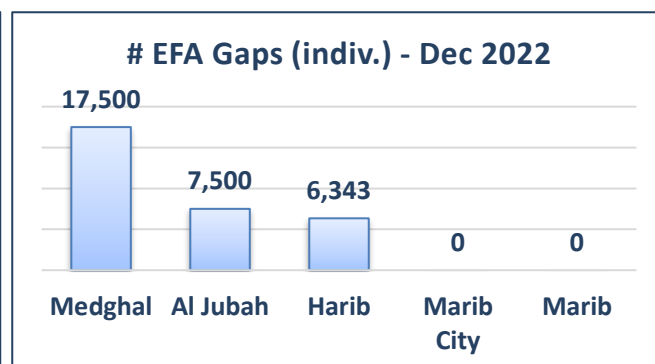
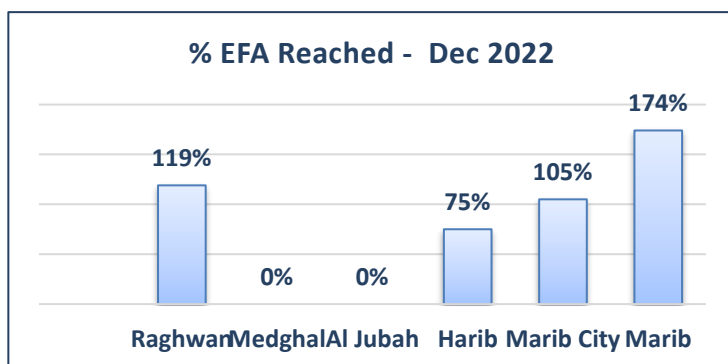
### 1. Action points from the last meeting:

### 2. FSAC partners' monthly updates; ongoing response & gaps:

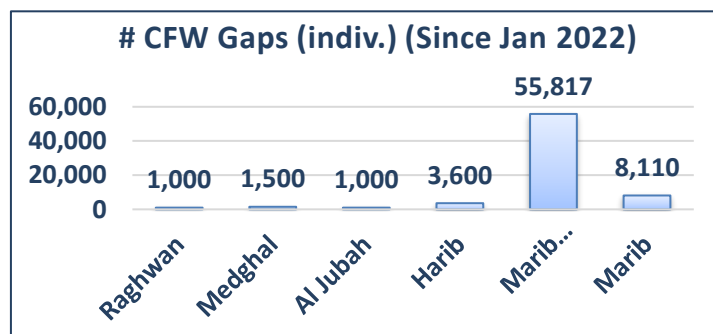
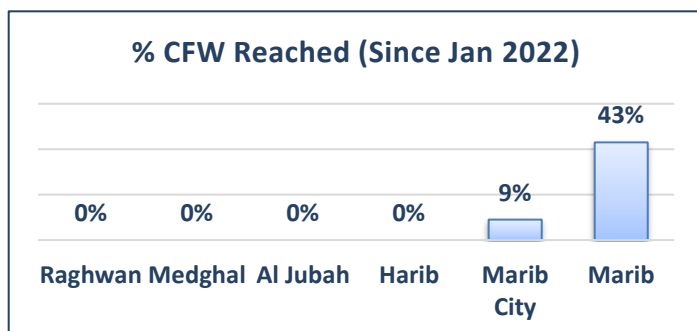
#### Emergency Food Assistance (EFA)

- 78,866 HHs have benefited each month from EFA in 2022, on average.



#### Livelihoods

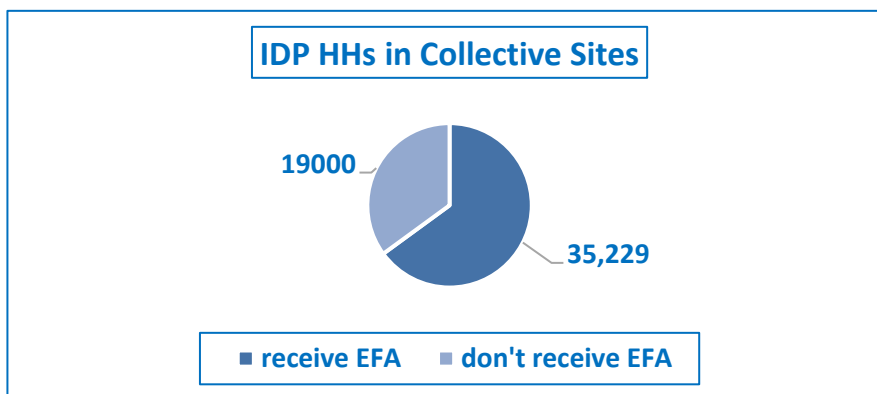
- Since Jan 2022, 18,202 individuals have been assisted with livelihood activities.

**FSAC Response to IDPs:**

- 35 % of IDPs residing in collective sites don't receive EFA.



• Out of 54,229 IDP HHs, 19,000 are NOT included under EFA monthly response.

**Partners updates:**

- Oxfam is distributing the last and 6<sup>th</sup> cycle of UCT to 1200 HHs, while also preparing to distribute the 5<sup>th</sup> cycle of another funded UCT to 500 HHs.
- CARE has completed the fourth UCT cycle in Marib City and Marib Wadi districts.
- SI is distributing the 3<sup>rd</sup> UCT cycle.
- ACTED is targeting 20 HHs with livestock, in line with the livestock distribution guidelines.
- YDH is distributing the 5<sup>th</sup> cycle of UCT to 50 HHs.
- IRY and NFDHR are waiting for the agreement between WFP and local authorities to distribute the 7<sup>th</sup> and 8<sup>th</sup> cycles of 2022.

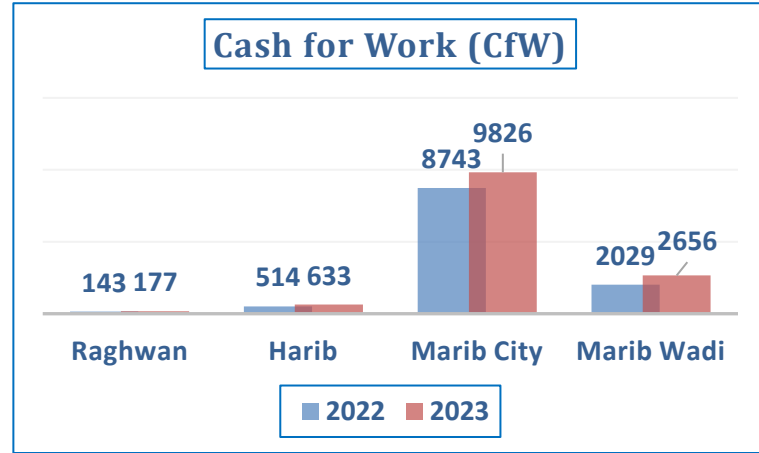
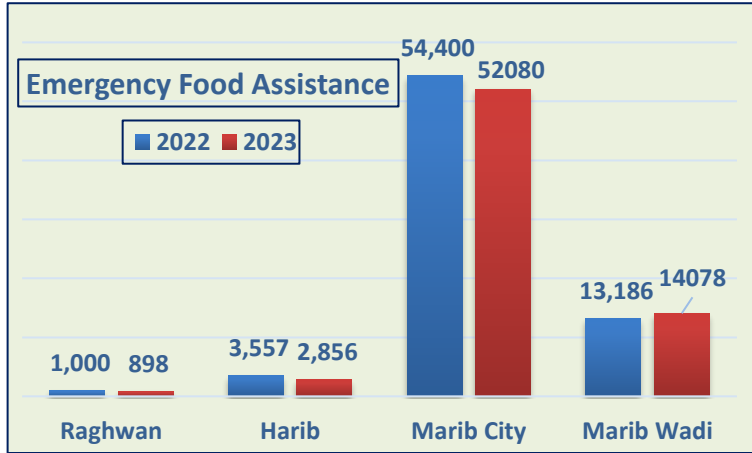
IPC Update in Q4:

## **5. AOB**

### **WFP 7<sup>th</sup> and 8<sup>th</sup> cycles:**

- CCCM Cluster, CCCM partners, and the Ex.U have raised concerns about the delayed distribution of WFP food baskets. They have added that the delay in distributing food to the vulnerable families in the governorate, especially during the current severe cold, portends a humanitarian catastrophe.
- WFP stated that its warehouses are full of food aid, and partners are ready to distribute the 7<sup>th</sup> and 8<sup>th</sup> cycles of 2022. They are still waiting to reach a final agreement with local authorities.
- FSAC indicated that the issue had been raised to the National Level and a senior level in the WFP Aden office.

### **Action points**

- FSAC will follow up with WFP & local authorities and inform the CCCM Cluster in case of any updates.
