2. Update the Mapping Matrix (FSAC partners) 2022/2023

- Participants provided briefing on their 20222/2023 activities. SCI, Oxfam, and WFP/BFD have funded livelihood activities for 2023
- Some FSAC partners stated that they are mobilizing resources and have yet to secure funding for their 2023 response plans
- As 2022 comes to a close, FSAC partners in Saáda hub need to update their plans during the period from November 1, 2022, through December 31, 2023.
- Partners should provide all the necessary details about their activities including sub-district and village details, distribution timeline, number of targets and planned cycles etc.
- We kindly request that partners submitting their response plan to indicate whether the planned activities are funded or not

Action points

- Partners are encouraged to mobilize resources to respond with food assistance to any newly displaced people
- Partners with available resources have to coordinate with the Sub-Cluster Coordinator and address the food gaps of the reported IDPs

4. FSAC membership application

- New partners who are interested to join FSAC should complete and submit the <u>online application</u> form
- Interested new partners need to upload the supporting documents as the application will not be processed and considered without the supporting documents
- Applicants will be notified about the application process and they can follow up on that through the concerned sub-cluster coordinator/s
- Eligible applicants should meet the membership criteria including the following:
 - o Adhere to the Cluster Principles.
 - o Adhere to the FSAC Guidelines and technical standards.
 - Coordinate your food security and livelihood related activities with the FSAC prior to their implementation, to avoid any potential duplication and/or overachievement.
 - Share information on your food security and livelihood activities (both implemented and planned), to feed the FSAC information management products and to facilitate the FSAC coordination.
 - Share any relevant documents (assessment reports, baseline / end-line evaluations, other), to contribute to a better understanding of the food security situation at national and sub-national level.
 - Take part to FSAC activities (concerning both the coordination and the information management), to contribute to its positive development and success.
- Failure to comply with the above requirements will result in the exclusion from the FSAC.

6. Regular response updates (achievements, gaps, and challenges)

- WFP completed the distribution of the fifth GFA cycle in Saáda and Al Jawf and started dispatches for the GFA sixth cycle
- WFP resumed its FFA activities in Barat Al Anan, Rajuzah, and Haydan districts as of November 2022. WFP/BFD will target 367 households in Barat Al Anan, 441 households in Rajuzah, and 245 households in Haydan.
- In Al Jawf governorate, UNHCR/YARD supports 85 households with livelihood-related activities in Kharab Al-Marashi, AlHumyadat, and AlHazm districts. Women are trained in productive home gardening skills, livestock breeding for livelihood improvement, making and marketing perfumes and incense, and handicrafts (Embroidery and Knitting).
- NDEO the agreement was signed to distribute 50 hand tractors for farmers to prepare agricultural lands for planting in Al Matammah district, Al Jawf governorate. The distribution process will take place during November 2022.
