- BCHR
 - Regular WFP GFD distribution to 36,712 the beneficiaries in Hadramout.
 - Response to 350 IDPs in in AL Abr district of Hadramout governorate.
 - Continuation of FFA activities in Hadaramout
 - Response to the IDPs and people in need from KSRC
 - 1200 in Soqatra
 - 210 HHs in AL Maharah
- FMF
 - Regular WFP GFD distribution to the beneficiaries in Hadaramout governorate (13 district in Wadi and 3 in the coastal area) about 21,034 GFD to the beneficiaries.
 - Response to IDPs in Hadramout.
 - Completion of FFA activities in Hadaramout.
- SHS
 - Regular WFP Cash transfer distribution to 1,846 beneficiaries in Shabwah governorate.
 - Response to the IDPs in Usylan and Ataq.
