## 3 October 2022 Cadre Harmonise (CH) Preliminary Result -By NPFS/FMARD


The October 2022 CH analysis covered the 26 States namely; Adamawa, Bauchi, Benue, Borno, Gombe, Jigawa, Kaduna, Kano, Katsina, Kebbi, Niger, Plateau, Sokoto, Zamfara, Taraba, Yobe, Abia, Cross river, Edo, Enugu, Lagos, Kwara, Kogi, Nasarawa, Ogun, Rivers States and the FCT; and was conducted at the zonal (senatorial) level with the exception of Adamawa, Bauchi, Borno and Yobe States that were analyzed at LGAs level.


The CH was conducted based on the analysis of outcome indicators of food and nutrition security and contributing factors (key drivers and limiting factors). Contributing factors are Flood impact, Insecurity (insurgency, kidnapping and banditry), Population displacement, Limited physical and economic access to food, High food prices, Limited income generating activities, Inflation rate (CPI) loss of job and other livelihood activities, Prevalence of sickness & diseases, etc.

#### **Findings**

The total number of people in need across 26 states in the country is 17 million for the current situation (October- December 2022) and 25 million for the projected situation (June-August 2023)

## **Current and Projected Situation for the BAY States**

#### Recommendations

- Humanitarian agencies should urgently secure resources to sustain the implementation of lifesaving interventions of food assistance and unconditional cash transfers (social welfare package) to the vulnerable populations in the affected areas.
- Promote various resilience-building interventions for households through MSMEs, prioritizing
  the vulnerable populations to enable them to get a fresh start-up for their livelihood and dryseason agricultural production inputs;
- Sustain the facilitation of humanitarian access to inaccessible/hard-to-reach areas so as to provide life-saving assistance and livelihood protection interventions to those in critical need.
- Continue to complement the efforts of the government in implementing the recommendations
  following the outcome of CH analysis, especially as it affects the populations and areas identified
  to be at risk of food and nutrition insecurity.

- 4 Cropland Change Analysis for Hard-to-Reach Areas in Northeast and Northwest By WFP
  The cropland change analysis for the 2022 rainy season covered 44 LGAs in north-eastern and northwestern Nigeria, including:
  - Borno: all LGAs in Borno North SD
  - Katsina: selected LGAs in Katsina Central and Katsina South SDs
  - Sokoto: all LGAs in Sokoto East SD and selected LGAs in Sokoto North and Sokoto South SDs
  - Zamfara: all LGAs in Zamfara State (Zamfara North, Zamfara Central and Zamfara West SDs)

The Areas of Interest (AOIs) were selected based on their accessibility and the need for data to inform the October 2022 Cadre Harmonisé analysis.

### **Findings**

For northern Borno:

- Severe decrease in cropland since 2010, corresponding to nearly half the population living in those areas
- Only sites sharing border with Yobe show increase between 2010-2022
- Between 2021 2022, apparent recovery, but not yet reaching the 2010 cropland availability For NW states:
- Between 2017 2022, decreases observed in Sokoto and Zamfara. Majority of areas (around 70%) show no changes.
- For 2021 2022, slight positive changes in Katsina and Zamfara state



#### Use and Recommendations

- Cadre Harmonise analysis
- Targeting for livelihood programming, for populations previously unable to conduct normal farming activities
- Targeting for rapid response mechanisms areas seeing severe agricultural decline
