# 1. Review of previous meeting action points

- SCI to communicate with OCHA the challenge of delayed signing the SA for food security project by looping FSAC SNCC for advocacy.
- $\checkmark$  Done- the sub-agreement was signed in the last week of July.
- FSAC sub-cluster to work with key partners and organizations to advocate for CFW interventions and road reconstruction in Bani Al Awam district.
- $\checkmark$  Ongoing- FSAC and WFP to discuss the concern in the 1st week of August.
- The sub-cluster coordinator to communicate the updated mapping matrix, as well as gaps in EFA, CFW, and Livelihoods, with partners for their review, consideration, and further coordination.
- ✓ Done.
- > YRCS to cross-check the lists of BNFs registered by field teams in Hajjah City and Ku'aydinah districts with other partners that have ongoing operations in these areas.
- ✓ Done with WFP and CARE.
- FSAC partners to mobilize the resources for the floods response and effectively coordinate with the relevant/key stakeholders for any potential assessment and support.

# 2. IDPs responses, updates, and gaps


- RRM IDPs in Hajjah ( January-July 2022) Update on Response and Gaps
  - As of July 24, 1,256 HHs are IDPs in 18 districts of Hajjah. The source is RRM List.
  - The biggest numbers of New IDPs are reported in Abs, Kushar, Mabyan and Hajjah city.
  - 12 HHs are the new IDPs displaced between 25<sup>th</sup> of June and 23<sup>rd</sup> of July which is considered the smallest recorded in the last few months.
  - 1,139 HHs of the IDPs are affected by conflict while 117 HHs are affected by Natural disasters; flooding.



- NRC and CARE included over than 660 HHs of the New IDPs in ongoing interventions.
- SCI planned to assist 11 HHs in Bani Qais, SSFD Planned to assist 19 HHs in Shares.
- 60 HHs of New IDPs in Kuhlan Ashraf are referred to CARE to be targeted in newly scaled up intervention.
- The total gap in RRM lists is 500 HHs that will be referred to partners have plans in the districts host IDPs
- Below is breakdown for the number of New IDPs, response and gaps in district level which is as follows:

For the IDPs in collective sites within Hajjah sub-hub, FSAC presented the gap at IDPs site in all districts of Hajjah as per the chart below



• The verified gaps indicated that 4,391 HHs of IDPs, which represents 6% of the total IDPs in settlements, are in a need for food assistance.



- The number will be increased after August as NRC's intervention in Washhah which serves around 3,000 HHs is going to be concluded in the coming two months.
- OXFAM started a YHF project that serves 1,200 HHs in Aslem; 70% of the targeted families are IDPs in collective sites.
- ICRC/YRCS will support 1,515 HHs with one off distribution of EFA in 13 collective sites within Abs district.
- SCI prepares to distribute the first round of UCT that serves 2,000 HHs; most of them are IDPs.
- SFD has plan to engage 102 HHs of IDPs in CFW activities in Hajjah city.
- YGUSSW reports ongoing livelihoods intervention that serves 360 HHs of IDPs in settlements in Khayran Al Muharraq, Washhah, Mustaba and Aslem districts providing CFW, small micro initiatives and livestock support.
- FSAC partners to coordinate on the ground with CCCM partners during the response.

#### 3. Regular FSAC Partners' Update on Response, gaps and challenges:

- In June 2022, 647,621 individuals have been assisted with monthly emergency food assistance within 16 districts of Hajjah.
- FSAC targets in 2022 Target is 1,756,000 individuals. The response in June covers only 37% of the target.
- 11 active FSAC partners provided emergency food assistance in June 2022; WFP, Ksrelief, UNHCR, YHF, RADF, BCHR, NRC, CARE, DRC, NFDHR, OXFAM and SFHRP.



• For the gaps, FSAC presented the EFA gaps in Hajjah as per the below chart.

- For Livelihoods and CFW, 6,412 individuals have been assisted with livelihoods and CFW assistance in May 2022.
- As of June, 63,424 individuals have been supported with livelihoods and CFW assistance accumulative from January to June 2022.

- FSAC 2022 target under this objective scores only 15% of the total target for 2022 which is 433,600 individuals.
- Four partners only were involved in implementing livelihoods assistance during June which are UNDP, CARE, SFD, and YGUSSW.
- Planned interventions are reported by SFD, ICRC/YRCS, ZOA, FAO, WFP, SCI, YGUSSW and which are reflected in the FSAC sub-district& village level mapping.
- FSAC Sub-district and Village level mapping matrix includes details on the planned livelihoods and CFW interventions of confirmed funding.
- Regarding the gaps in livelihoods and CFW targets, below is breakdown for the gaps in districts level which are as follows:

• For partners' regular update on June response, FSAC sub-cluster partners report the following:

 NRC started delivering cash support to families and New IDPs in Bani Othabi and Matwalah sub-districts of Abs district. The targeted households in Matwalah are 375 HHs, who will receive one MPCA cycle, whereas the targeted families in Bani Othabi are 981 HHs, of whom 199 will receive six cycles and the remaining 782 will receive only three cycles.

# VEMEN FOOD SECURITY & AGRICULTURE CLUSTER

- NRC also distributed the fifth cycle of UCT that targets 2,953 HHs in Washhah and the fourth cycle that targets 751 HHs in Qarah district.
- CARE started the distribution the fourth round of unconditional cash assistance for 1,746 HHs in Abs district, 892 HHs are in Bani Othabi sub-district.
- Ongoing distribution for EFA allocated for the 4<sup>th</sup> cycle provided by WFP through 6 IPs that targets around 1.4 million of people in 29 districts of Hajjah.
- BCHR concluded the distribution of the EFA for June cycle that targets 4,787 HHs in IRG areas of Hajjah; 865 HHs in Midi, 740 HHs in Haradh, 2,930 HHs in Hayran, and 252 HHs in Bani Hasan sub-district of Abs district.
- ICRC, through YRCS, plans to distribute one off emergency food assistance for 1,515 HHs in 13 IDPs Collective Sites within Abs district, 303 HHs in Hajjah city and 303 HHs in Kua'ydinah district.
- OXFAM started the distribution of the 2<sup>nd</sup> cycle of unconditional cash assistance for 1,200 HHs in Aslem district.
- RADF distributed MPCA for 4,000 HHs in several districts of Hajjah during July.
- SSFD reported completed distribution for livelihoods support assisting 750 HHs in Bani Qais and Mabyan districts providing beekeeping kits, agricultural kits and livestock kits for the small farmers in the aforementioned two districts.
- CARE completed the distribution of the second round of CFW assistance for 200 HHs in Ku'aydinah district.
- ICRC plans to provide cash for seeds assistance for 2,500 farmers supporting them in attaining seeds for the next season.
- ZOA and SDF have reported joint project in Bani Alawam and Shares districts.
- SCI reports ongoing implementation for livelihoods project of longer-term support as vocational training and kits for 300 HHs in Abs and Hajjah city.
- SFD reports ongoing implementation for CFW and agricultural activities in Washhah, Kushar, Abs and Al Maghrabah districts.
- SCI reports planned project in Bani Qais and Ash Shaghaderah districts targets 1,013 HHs.
- In July, SCI has received signed SA for food security project in Abs and Bani Qais district.
- FSAC partners report key challenges facing the implementation of food security interventions which are as follows:
  - The variations of exchange rate for EUR against USD for project budgeted in EUR.
  - The increased needs especially for livelihoods assistance.
  - Logistics issues during the delivery of the assistance to some DPs especially in districts like Bani Al Awam.

#### Action points

- SCI to update FSAC about its planned intervention in in Ash Shaghaderah and Bani Qais districts and to share more details on the ongoing intervention in Abs and Bani Qais; number of IDPs targeted, # cycles, amount of assistance..etc..
- All pertinent FSAC partners, which planning for one-off cycle food assistance distribution to ensure prior coordination.

  - Partner Presence Map: displays FSAC partners active in the different locations during any selected month.
  - Monthly Response Dashboard: displays FSAC partners' responses and beneficiaries assisted during any selected month.
  - Unique Beneficiaries Dashboard: displays the unique beneficiary figures reached by FSAC partners since January 2022.
  - Cash and Voucher Assistance Dashboard: displays cash and voucher assistance implemented and beneficiaries assisted by FSAC partners during the selected month.
  - Gap Analysis Strategic objective 1 dashboard: displays the geographic gaps where the number of the BNFs assisted is lower than HRP SO 1 target.
  - Gap Analysis Strategic objective 2 dashboard: displays the geographic gaps where the number of the BNFs assisted is lower than HRP SO 2 target.

# Floods Response

- Rainfall season started in Hajjah in the second week of June in which alerts are received from partners in several districts of Hajjah.
- Till 27<sup>th</sup> of July, 90 HHs are affected by floods in Hajjah city, Ku'aydinah and Shares districts.
- FSAC sub-cluster is working closely with OCHA, SCMCHA, FSAC partners and other sub-clusters for the assessment and response.

#### Action points

- FSAC to share the alerts of the floods affected families with FSAC partners for the mobilization of the resources, verification, and response.
- All pertinent FSAC partners planning for the flood response should ensure prior coordination with FSAC.
