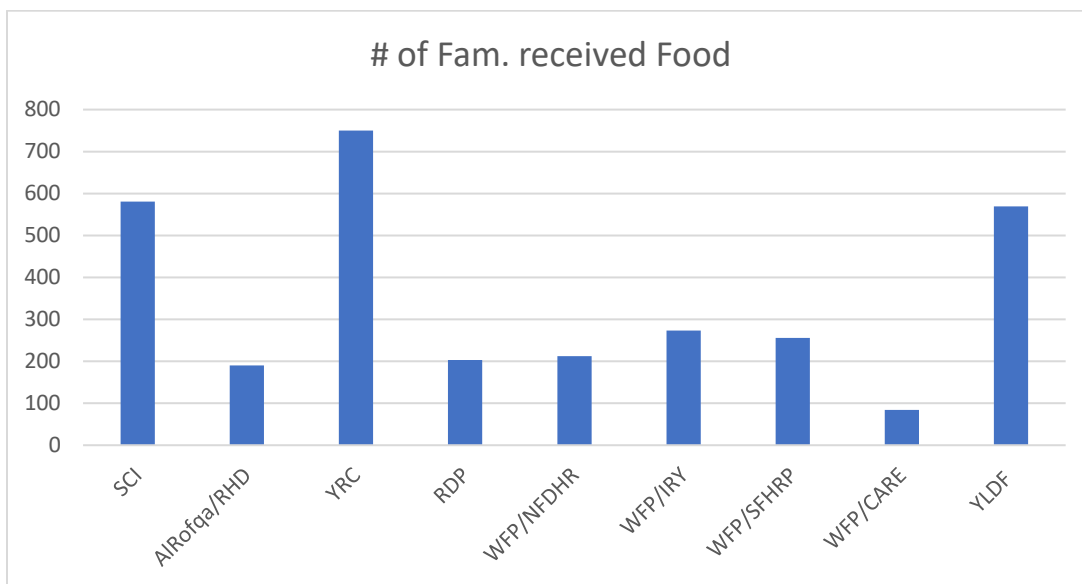
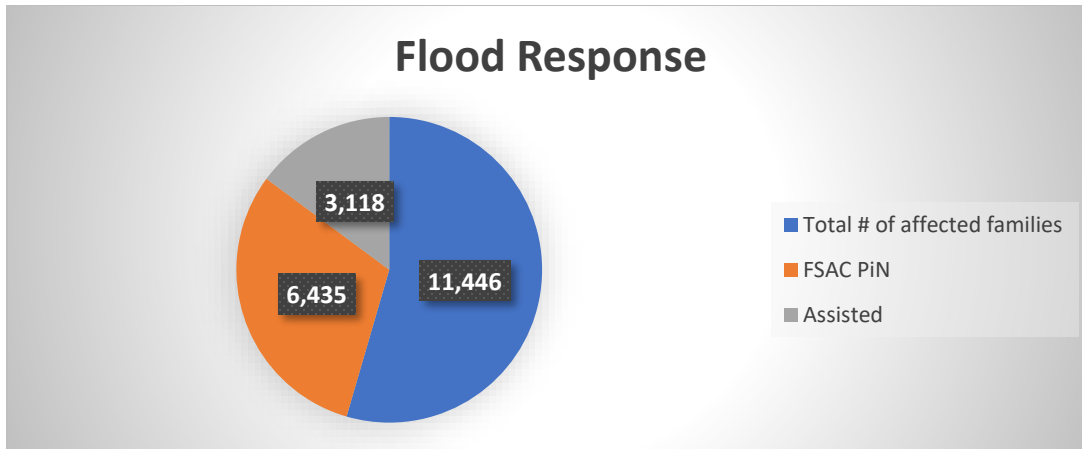

1. Review of previous meeting action points

- FSAC's partners to mobilize the resources for the IDPs response and coordinate for the relevant response prior to the implementation.
 - ✓ Standing out Action Point
- FSAC's partners to ensure reporting the relevant response on monthly basis to the FSAC IM team.
 - ✓ Standing out Action Point
- FSAC SNCC to communicate with WFP to get more information on the changing of CTVN targeted areas.
 - ✓ Done. This is confirmed by WFP and applicable to all hubs. This is due to the funding resources situation plus suppliers' capacities due to the global prices!

2. FSAC Response for Floods-Affected Families in Sana'a hub

- The below chart and table show the response under Sana'a hub :



➤ **Partners feedback;**

- QC is in the process of delivering their assistance in Dhamar for 900 HHs.
- FSAC mentioned that Y30 planned to assist 20 HH in Sana'a, Arhab district.
- ADRA is planning to cover 350 HHs in Jahran district, Dhamar governorate.

Action Point:

- QC & ADRA are requested to coordinate their flood response in Jahran district and crosscheck the BNF list to avoid any potential duplication, FSAC SNCC will share the contact details of QC & ADRA focal point.

3. Regular response updates achievements, gaps, and challenges:

- In July 2022 3,187,278 individuals have been assisted with monthly emergency food assistance within 6 governorate of Sana'a hub.

- FSAC targets in 2022 Targeting Sanaá hub is **5,199,000** individuals. The response in July covers only **61%** of the target.
- The total food gaps under Sanaá hub is 2,296,817

➤ **Partners feedback ;**

- CARE, HA, IRY, NFDHR, MR, RAMZ, and ADRA shared their updates.
- Most WFP IPs reported that cycle #4 is almost finished. Except for some districts in Albayda and Marib as dispatching of food items is still ongoing.
- MR/CCCM partner in Amant alasimh reported the existing gap in IDPs sites in Dhaban center ,Alkhamees and Almoalameen sites. Besides, the need for livelihood activities within these sites.
- No major challenges reported by partners.

Action point:

- FSAC SNCC to share CCCM Weekly Tracking tool for sectors' Gaps in IDP sites under Sana'a hub.

4. FSAC Minimum Food Basket Transfer Value Guidelines: Unconditional Transfers

- Harmonised transfer values of the FSAC MFB for a household of 7 members will be YER 70,500/household/month in the northern governorates and YER 126,500/household/month in the southern governorates. This is equivalent to USD 126/household/month in the northern governorates and USD 123/household/month in the southern governorates.
- No changes on the composition of the FSAC MFB and it remains as follows:
 - Wheat flour 75 kg
 - Beans 10 kg
 - Vegetable oil 8 liters
 - Sugar 2.5 kg
 - Salt 1 kg
 - Possible addition of rice (based on community preferences): the MFB composition should be 50 kg of wheat flour and 20 kg of rice.

➤ **Partners feedback ;**

- ADRA reported that based on the PDM report, most beneficiaries indicated that the amount of sugar is very low in the composition of MFB. FSAC clarified the rationale for adding sugar to the MFB. Besides, the required quantity for 7 persons per month is 2.5 Kgs equivalent 54 Kcal equivalent/ 14.0 g only for the daily ration.

5. Technical Guidelines for Livelihood Conditional Cash Transfer (CCT)

- Currently many Agencies are involved in CCT programs in Yemen with the three main activities revolving around;
- Cash for Work (CfW) The two main objectives of CfW programmes are to:
 - Provide short term income opportunities, increase consumption of goods and enable HHs to meet their food needs; and
 - Build or repair assets and infrastructure that are vital for sustaining the livelihoods of a community.
- Food Assistance for Assets (FFA): focuses on restoring acceptable food security levels in the immediate term and supporting assets that directly or indirectly benefit the target population. Supported assets seek to strengthen the livelihood, resilience to shocks and food security and nutrition of targeted populations in the longer term.
- Public Works Programmes (PWP) The primary objective is to provide temporary employment for the working-age poor who are not able to find work or pursue their usual income-generating activities. They are normally administered in response to a crisis or

sudden shock and they typically focus on the maintenance of existing community infrastructure, and assets, or the provision of basic new infrastructure.

- The general Principles of CCT ;
 - All CCT programmes (CFW/ FFA/ PWP) must be based on a needs analysis. Before undertaking a CCT programme, it is critical to verify the following:
 - The average daily Local Market Unskilled Labor Rate (LMULR) at the Governorate level.
 - CCT activities will not interfere with the community's main livelihood strategies
 - Assets and infrastructure to be built or rehabilitated will meet the basic needs of the targeted population.
 - CCT values expressed in YER
 - The CCT values should be 10% higher than the unconditional cash transfer value (UCT) 7 individuals / HH(a) . $CCT = UCT * 110\%$.
 - IRG AoC, $126.500 * 110\% = 139.000$ YER;
 - SBA AoC, $70.500 \text{ YER} * 110\% = 77.500$ YER.
 - The suggested number of working days is 15 / per month
 - Six working hours should be considered as maximum working hours/day
 - CFW programmes should be for a minimum of 3 months and a maximum of 6 months
 - FFA programmes should be for 6 months
 - PWP programmes should be for a minimum of 3 months
 - Savings can be utilized as follows:
 - Partners to engage new participants to complete the ongoing activities,
 - Partners to provide more work days to the same beneficiaries (in the event that the savings made are not enough to engage new beneficiaries).
