## 1. Review of previous meeting action points

- SCI to update FSAC about its planned intervention in Ash Shaghaderah and Bani Qais districts and to share more details on the ongoing intervention in Abs and Bani Qais; number of IDPs targeted, # cycles, amount of assistance..etc....

## 2. FSAC Response for Floods-Affected Families in Hajjah

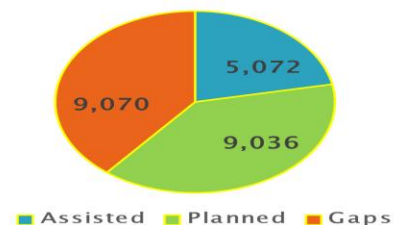
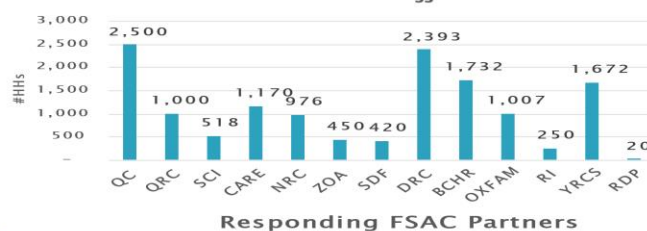
- Heavy rains have triggered extensive flooding across several governorates of Yemen since mid-July, affecting tens of thousands of people, mainly internally displaced people in hosting sites and settlements.
- Hajjah Governorate was also hit hard by rains and floods. SCMCHA, EXU and humanitarian partners reported an estimated of 23,000 HHs in 28 districts.
- According to local authorities, at least 42 people, including children, were reportedly killed by floods in Hajjah.
- OCHA and Sub-National Clusters are cooperating with partners to deploy a response as floods continue to threaten IDPs in Abs, Mustaba, Khayran Al Muharra, and Aslem districts, where over 350,000 people are housed in 250 displacement camps.
- Assessments have been concluded in 21 districts within Hajjah and ongoing in 4 districts conducted by RRM partners, CCCM partners and FSAC partners.
- 14,814 HHs have been verified out of the total reported number 23,178 HHs.
- The biggest number of the floods affected families is reported in Abs district in which five partners are proposed to conduct the assessment for almost 6,200 HHs not assessed yet. OXFAM, RDP, ZOA, SDF and SFHRP. SFHRP and OXFAM are on the ground while others are following up for the clearances.
- 63% of the reported affected families either received or will receive a planned support; 5,072 HHs received one off food assistance and 9,425 HHs will receive one off distribution of emergency food assistance in the coming days.

- New response plans are reported by WFP, HAI, IOM and SCI. more details will be shared in subsequent meetings.

### Action points

- FSAC to continue monitoring and mapping impact of floods, as well as mobilizing resources to cover gaps.
- SFHRP, DRC and OXFAM to share with the sub-cluster and OCHA the findings of the assessment conducted in Abs, Aflah Al Yaman, Aflah Asham and Aslem districts.
- All pertinent FSAC partners planning for a flood response should ensure prior coordination with FSAC.

### 3. FSAC/ Food Gaps in Hajjah

- FSAC presented the gaps in emergency food assistance both indicating almost 19,000 HHs are in need for food assistance in eight prioritized districts within Hajjah.
- Planned activities reported by partners in the coming months are considered in gap analysis.

#### Action Point:

FSAC partners to mobilize the resources for the response in the districts where the gaps ensuring any planned response should cover the gaps.

#### 4. Regular FSAC Partners' Response Update-achievements, gaps & challenges);

- In July 2022, 1,511,261 individuals have been assisted with monthly emergency food assistance within 31 districts of Hajjah.
  - FSAC targets in 2022 Target is 1,756,000 individuals. The response in July covers only 86% of the target.
  - 11 active FSAC partners provided emergency food assistance in June 2022; WFP, KSR, UNHCR, YHF, RADF, BCHR, OXFAM, NRC, CARE, RI, VHI, DRC, NFDHR, and SFHRP.
- For Livelihoods and CFW interventions, in July 2022 only 3,837 individuals have been assisted with livelihoods and CFW assistance.
  - As of June, 67,297 individuals have been supported with livelihoods and CFW assistance accumulative from JAN to July 2022.
  - FSAC target 2022 under this objective scores only 16% of the total target for 2022 which is 433,600 individuals.
  - The only Active partner in July is SFD.
  - Planned interventions are reported by WFP, FAO, SFD, RI, VHI, NFDHR, ICRC, ZOA, which are reflected in the FSAC sub-district & village level mapping.
- For partners' updates in August, FSAC partners reported the achievements which are as follows:
  - BCHR concluded the distribution of the EFA for August cycle that targets 4,787 HHs in IRG areas of Hajjah; 865 HHs in Midi, 740 HHs in Haradh, 2,930 HHs in Hayran, and 252 HHs in Bani Hasan sub-district of Abs district.
  - YRCS distributed the second cycle of emergency food assistance for 304 HHs in Hajjah city and 305 HHs in Kua'yadinah district.
  - OXFAM distributed the distribution of the 3<sup>rd</sup> cycle of unconditional cash assistance for 1,200 HHs in Aslem district.
  - NRC distributed THE sixth round of UCT for 1,710 HHs in Washhah district.
  - RADF distributed MPCA for 4,300 HHs in eight districts of Hajjah during August.
  - CARE completed the distribution of the second round of CFW assistance for 725 HHs in Kua'yadinah district and the fifth cycle of UCT for 1,747 HHs in Abs district.
  - SFD reports ongoing implementation for CFW and agricultural activities that targets 3,052 HHs in Washhah, Kushar, Abs Al Maghrabah, Khayran Al Muharraq, Ash Shaghaderah, Qarah, Bani Qais, Kua'yadinah and Aslem districts.
- For the challenges, ZOA reported one pending SA for food security project in Hajjah.

- RI to share with FSAC, the key-details related to its new FFT/FFA intervention in 16 districts in Hajjah.
