OBJECTIVES

- In collaboration with partners, support the assessment of impacts resulting from the conflict and the integration of environmental considerations into the humanitarian planning process and response.
- Support coordination and information sharing between humanitarian and environmental actors, as well as appropriate authorities, for greater knowledge, awareness, capacity building, and decision making on environmental concerns.
- Provide **technical guidance** to the UN and other partners on analyzing and addressing environmental risks and hazards arising from the conflict.

Environment and Food Security and Livelihoods (FSL)

FAO Environmental and Social Management Guidelines (2015; Interim 2020)

Management of Risk at Program and Project Levels.

5. Application of the standards is determined during FAO's social and **process**. Where it is determined that a project may present certain risks and/or impacts, requirements of the relevant standard(s) are triggered.

41. Requirements in projects under emergency preparedness and response are covered in the FAO in Emergencies Guidance emergency response, but also to improve Note on Accountability to Affected Populations (2013).

WFP Environmental Policy (2017)

54. Environmental risks in emergency operations will be addressed first through SOPs and preparedness measures, avoiding risks to the extent possible from the outset. Should the **rapid screening process** detect environmental screening and categorization any high risks that have not been addressed, preventive or remedial action will be incorporated where feasible and lessons learned will be integrated into SOPs and preparedness measures ahead of future operations. This approach will serve not only to avoid environmental damage during the environmental outcomes in the aftermath of rapid onset disasters.
