Food Provision at Reception Center

- 1. If the facilities can cope with the sudden influx of new arrivals?
- 2. How do we handle the issues of people coming at night?
- 3. Communal cooking space
- 4. Cooking fuel The Sector kindly asking PCNI/SEMA/NEMA for support if possible
- 5. Condiments The Sector kindly asking PCNI/SEMA/NEMA for support if possible
- 6. NFIs Communities cook for themselves
- 7. Milling facilities or alternative food items.
- 8. Clean water provision

Possible Operational modalities for hard-to-reach areas

ISWG is looking at possible operational modalities to respond in hard-to-reach areas. It was noted that this process must be in line with the Access Strategy, and that we should look to optimize existing mechanisms that have outreach to some hard-to-reach areas, including with FAO extension workers, WHO hard-to-reach teams, DTM enumerators, and Polio teams. To map out the areas covered by above existing outreach, OCHA is overlaying the available data to come up with a map and analysis.

Returns/ Relocations situation:

Following the decision made by members at the High-Level Task Force HLTF meeting chaired by H.E Deputy Governor held on the 12th July 2018 to activate the Return Task Force (RTF). The RTF meeting, chaired by the MRRR Commissioner, is slated for Wednesday 18th July 2018. The RTF ToR will be reviewed with the following main roles/responsibilities:

- Development of a comprehensive returns strategy and plan of action for Borno State, clearly defining the role of Borno State Government and the international community (UN and INGOs), owned and led by the Government of Nigeria (GoN) with contributions and support of the international community and other key stakeholders.
- This strategy contributes to the overall Federal Government of Nigeria Strategy on Returns under PCNI management.
- Report to the High Level Task Force Chaired by the Deputy Governor and provide regular updates and reports on the return process and the returns strategy implementation.
- Review of the Operational Standards for Relocation of IDPs in Newly Accessible Areas document, with a review of updating it to suite the current on return.
- Development of a work plan for the return process which takes into consideration information campaign, coordination, logistics and assessment on areas of return.



- Work in liaison with all relevant stakeholders, i.e. Nigeria military, local authorities, Government line Ministries, humanitarian actors to coordinate a sustainable basic service delivery (including Shelter, WASH, health and protection services) as well as food and non-food items distribution in areas of return.
- Collaborate with sectors and other stakeholders to ensure setting of and respecting humanitarian standards at all stages of the process;
- Develop messaging and clear communication lines with IDPs for the purpose of information sharing and coordination on the relocation process. Information sharing should include and not be limited to availability of services, security, mine risk education, etc.
- Develop a monitoring framework to measure the progress on access and provision of basic services, including risk education, resilience building, strengthening civil authority, promote self-reliance and restoration of social cohesion for reintegration and peace building.
- Development of monitoring framework for humanitarian and development, peace nexus
- Any other duties that may be assign to the RTF by the HLTF with regards returns

Updates from Rainy Season Task Force

- The meeting highlighted major issues from various partners updates, this was rounded up by the presentation/discussion on Oxfam experience on beneficiary targeting for Agriculture & Livelihood Activities, its recommendations and Lessons Learned. Partners share their experience in beneficiary targeting.
- Key highlights/areas for improvement from the TF meeting include:
 - o Community sensitization /CwC
 - o Inclusion or engagement of youths in our programming
 - o Late in distribution (crop seeds in particular)
 - o Follow-up distribution with training, monitoring and use of extension services
 - Do No Harm Avoid distributing crop seeds that may put communities' safety at risk
 - o Beneficiary targeting for Agriculture & Livelihood Activities community sensitization, community committees and use of FS technical indicators
 - Urban/Micro/Kitchen/Backyard gardening to be discussed in TF meeting.

Updates from Targeting Task Force meeting

The Sector reactivated the Targeting Taskforce to revise the sector targeting guidance notes. The TF members reviewed the document highlighting crucial issues from lessons learned and areas in which the sector need to improve on. Issues include:

- Community engagement and sensitization
- Glossary of technical terminology (survey, census, registration....)
- Addressing the issue of new arrivals and population movement
- Recommended use of IOM/DTM bio-metric data where possible
- Data protection and beneficiary consent prior to data sharing

Updates from the Gender/GBV/Protection/PSEA one-day training for FSS Borno partners.

The key recommendations /areas for actions from the training were:

- Referral pathways for GBV and Child Protection cases.
- Protection questions in post distribution monitoring activities.
- PSEA focal point within FSS member organizations.
- Code of Conduct template and IEC materials on SEA Do's and Don'ts.
- Contextualized guidance on Child Protection in the context of NE Nigeria.
- Guidance on Complaint and Feedback Mechanism.

The training will also be held in Adamawa and Yobe in the coming weeks. Details will be shared once it is confirmed.

6 PARTNERS UPDATES

General Communique from Oxfam on its program closure in NE Nigeria

- Oxfam is closing its administrative office in Maiduguri and operating base in Pulka after
 a two-year operation. Oxfam has been scaling-back this humanitarian program
 specifically in Damboa and Gwoza for the past few months. Oxfam's long-term
 development programs throughout the rest of Nigeria will continue as normal, as will
 its humanitarian responses in neighboring Chad and Niger.
- Whilst Oxfam are currently developing their operational closure plans and aim to have these done by August 2018. Key to this process will be engagement with the various sectors to ensure that humanitarian partners will be in a position to continue providing support to the communities with which we are working.
- Oxfam has already started discussions with sectors and partners to see how other partners could take over activities they are currently implementing and will continue engaging with their humanitarian partners during this transition.
- In addition, Oxfam is ready to provide technical support and assistance if any FSS partners are interested.

NEMA:

- NEMA food distribution for July commenced today, 17 July.
- NEMA clarified that there was no June cycle of NEMA distribution as the May cycle ended in June.
- NEMA requested the sector to facilitate and coordinate their request to WFP on phasing out from Farm center (where NEMA is responding) and taking Custom House into consideration. -> The Sector updated that the discussion between WFP, NEMA and FSS is ongoing. WFP in response provided an update as regards the request stating that there was a meeting with NEMA where the issue was discussed and agreed but it

This reduced the number of beneficiaries from 81,000 to 51,000 individuals. In achieving this process	
	proper sensitization was done for 3 months and biometric registration was extended and it is still ongoing. Beneficiaries are receiving full rations. It important to state that the resistance of some beneficiaries to biometric registration as they do not want to lose their duplicated ration cards.
